James C. Riley

Taking French participation in the Seven Years War as a case study, this book examines the effects of war on the economy and on government finance, finding that the economic toll has usually been exaggerated and the financial toll seriously underestimated. Responding to French loathing of taxation, the authorities chose to finance this war chiefly by borrowing. Newly discovered documents from archives outside France reveal the scale of revenues, expenditure, and debt, matters previously obscure because of the destruction of French records in archival fires.
