Contributions should be typed double-spaced; tables and footnotes, also double-spaced, should be grouped separately at the end of the paper. Four copies of each manuscript should be submitted. A submission fee equivalent to a year's membership (fee schedule above) is required from nonmembers of The Economic History Association. Prospective contributors may obtain from the Editorial Office a copy of "Suggestions to Contributors," a list of the major literary and stylistic customs of the JOURNAL.

The JOURNAL does not accept unsolicited book reviews, nor does it honor individuals' requests to review particular works. Reviews are indexed each December in the *Book Review Index*.
