Banking in the American South from the Age of Jackson to Reconstruction presents a thorough review of the early banking history of the South by analyzing the division between banking policies and economic ideas in the states of the Old and the New South. Larry Schweikart's study revises previous research in many ways. It is unique in its focus on southern banks and the relationships between banks, politics, and the economy. Schweikart discusses bank operations, laws governing banks, the effects of various national regional crises and booms, and the relationship between banks and capital supply. This study shows how most banking systems were destroyed during the Civil War by Confederate bond issues, inflation, taxation, and the Union occupation, and how the destruction of southern banks severely retarded attempts to reestablish the southern economy after the war.

The Economy of Early America

The Revolutionary Period, 1763-1790

Edited by Ronald Hoffman, John J. McCusker,
Russell R. Menard, and Peter J. Albert

By the second half of the eighteenth century an elaborate commercial economy flourished in British North America. Although considerable diversity characterized the various regions that composed this economic system, and levels of prosperity differed within and between these areas, contemporaries viewed Britain's colonies as places that offered opportunities for substantial material advancement. Moreover, despite the primary emphasis on commerce and agriculture, an increasing interest in manufacturing presaged the first steps in the transition from a preindustrial to an early industrial economy.

In the opening essay James F. Shepherd provides an overview of the course of American overseas trade between 1763 and 1790. James A. Henretta's article explores the impact of the American Revolution on the nation's domestic economy. The following six essays have a regional focus. The articles by Winifred B. Rothenberg, Thomas M. Doerflinger, and John J. McCusker are primarily economic studies. They describe the salient features of specific regional economies and explicitly or implicitly attempt to evaluate the effect of the Revolution on their development. The articles by Lewis R. Fischer, Joseph A. Ernst, and Russell R. Menard focus on why the respective colonies that are the subjects of their essays did or did not choose independence. Jacob M. Price concludes the volume by surveying some of the major topics relating to the economy of Revolutionary America.
