NOTES ON THE CONTRIBUTORS

FERNANDO HENRIQUE CARDOSO is Director of the Brazilian Center for Analysis and Planning (CEBRAP). He has been a Visiting Professor at many universities in Latin America, the United States, and Europe and consultant to various organizations including the UN and CEPAL. His book *Dependency and Development in Latin America*, in collaboration with E. Faletto, will soon be published in English.

JAMES H. STREET is Distinguished Professor of Economics at Rutgers University and a member of its Latin American Institute. He is the author of articles on Argentine economic development, the structuralist movement, and technological dependency in Latin America.

JERRY L. INGLES is a Research Associate with the Program on Policies for Science and Technology in Developing Nations, Cornell University.

LORETTA FAIRCHILD is Assistant Professor of Economics at Nebraska Wesleyan University, currently doing comparative research on patterns of technology transfer via foreign investment in India, Central America, Mexico, Colombia, and Brazil.

DILMUS D. JAMES is Associate Professor of Economics at the University of Texas at El Paso. Publications and research activities have focused on science and technology policy in developing countries, an appraisal of dependency analysis as applied to Latin America, and the economy of the U.S.-Mexican border region.

JANE M. LOY is Associate Professor of History at the University of Massachusetts. She has authored several publications on film and on the history of primary education in Colombia during the nineteenth century. Her current research interest is in preparing a history of the Colombian Llanos as a tropical plains frontier from colonial times to the present.

TERRY J. PEAVLER is Assistant Professor of Spanish and Comparative Literature at the Pennsylvania State University. He is author of several articles on Latin American literature and is currently working on the contemporary novel and on Cuban literature.

LAURA RANDALL is Associate Professor of Economics at Hunter College, CUNY. Her latest book, *A Comparative Economic History of Latin America, 1500–1914*, will be published by University Microfilms.

ROBERT C. MADDOX is Associate Professor of Management at the University of Tennessee at Knoxville. He is the author of various articles on management and organizational behavior.

BARBARA G. COX is Associate Librarian and Editor of the Hispanic American Periodicals Index. She was the Latin American and Romance Language bibliographer at Arizona State University until 1976 and is now working under a grant from the National Endowment for the Humanities at the UCLA Latin American Center.
