## Contributors

*Edward J. Balleisen* is associate professor of history at Duke University, senior fellow at Duke University's Kenan Institute for Ethics, and author of *Navigating Failure: Bankruptcy and Commercial Society in Antebellum America* (2001). With David Moss, he coedited *Government and Markets: Toward a New Theory of Economic Regulation*, an interdisciplinary collection of essays on regulatory policy, forthcoming from Cambridge University Press. His essay in these pages is part of a larger research project on the history of commercial fraud in the United States.

*David J. Cowen* is managing partner of Quasar Capital Partners, LLC, a macro hedge fund. He is the author of *The Origins and Economic Impact of the First Bank of the United States, 1791–1797* (2000), and co-author (with Robert Wright) of *Financial Founding Fathers: The Men Who Made America Rich* (2006). His article "The First Bank of the United States and the Securities Market Crash of 1792," published in the *Journal of Economic History* in December 2000, was co-recipient of the 2000 PEAES award for best journal article in early American Economic History.

*Eric Hilt* is assistant professor of economics at Wellesley College and faculty research fellow at the National Bureau of Economic Research. His research focus is on the history of American business organizations and their governance, and, more generally, on the role of legal institutions in shaping economic and financial development. His recent publications include "When Did Ownership Separate from Control? Corporate Governance in the Early Nineteenth Century" (2008) and "The Limited Partnership in New York, 1822–1858: Partnerships without Kinship" (forthcoming), both in the *Journal of Economic History*.

*Naomi R. Lamoreaux* is professor of economics, history, and law at the University of California, Los Angeles, research associate at the National Bureau of Economic Research, and fellow of the American Academy of Arts and Sciences. She is the author of *The Great Merger Movement in American Business, 1895–1904* (1985) and *Insider Lending: Banks, Personal Connections, and Economic Development in Industrial New England* (1994), and she has edited several books and published many articles on business, economic, and financial history. She is currently exploring patenting and the market for technology in the United States



and looking at business organizational forms and contractual freedom in Europe and the United States during the nineteenth and twentieth centuries.

*Thomas Max Safley* is professor of history at the University of Pennsylvania, where he teaches economic and social history of early modern Europe. He is the author of a wide range of articles and books, including *Children of the Laboring Poor: Expectation and Experience among the Orphans of Early Modern Augsburg* (2005). His two-volume history of poverty and charity in early modern Augsburg is being translated for publication in Germany and will appear in 2008 and 2009 as *Kinder, Caritas und Kapital*. An upcoming book, entitled "Bankruptcy: Economics and Ethics in a Capitalistic Age" (a close study of bankruptcy and its economic and ethical implications in early modern Europe), will be published soon.

*Richard Sylla* is Henry Kaufman Professor of the History of Financial Institutions and Markets and professor of economics at the Stern School of Business, New York University. He is a research associate at the National Bureau of Economic Research and vice chairman of the board of trustees of the Museum of American Finance, a Smithsonian affiliate in New York City. He is conducting research on the financial development of the United States in comparative contexts. With Robert E. Wright, he is documenting and interpreting the growth of corporations in the United States from 1790 to 1860.

*Robert E. Wright* teaches business, economic, and financial history at New York University's Stern School of Business. He is the author, or co-author, of ten books, including most recently *One Nation Under Debt* (2008). He also edits Pickering and Chatto's financial-history monograph series and is a curator for the Museum of American Finance. He and Vincenzo Quadrini teamed with Flat World Knowledge to produce a textbook on money and banking that will be published in the spring of 2009.
