Peter Baldwin is Professor of History at the University of California, Los Angeles. He is the author of several works on the comparative history of modern Europe and the United States, and most recently *The Narcissism of Minor Differences: How America and Europe Are Alike*.

Richard J. Evans is Regius Professor of History and President of Wolfson College, University of Cambridge. He is the author of a number of books on modern Germany and on historiography, including *In Defence of History* (Granta, 1997) and *Cosmopolitan Islanders* (Cambridge University Press, 2009). He is currently writing the volume on 1815–1914 in the Penguin History of Europe.

Fritz Georg von Graevenitz is finalising his PhD at the European University Institute, Florence (Italy). He works on internationalism and agriculture in the interwar period. His most recent publications are ‘From Kaleidoscope to architecture: Interdependence and integration in wheat policies (1927–1957)’, in Kiran Klaus Patel, ed., *Fertile Ground for Europe? The History of European Integration and the Common Agricultural Policy since 1945*, (Baden-Baden: Nomos, 2009), 27–34, and ‘Changing visions of the world sugar market in the Great Depression’, in *European Review of History*, 15, 6 (2008), 727–747.

Cornelia Knab is Research Associate in Modern History at the University of Heidelberg. Her research focuses on the history of international organisations, transnational civil society, and scientific internationalism in nineteenth and twentieth century with a special interest in the history of the League of Nations. She is currently working on her doctoral thesis about the handling of animal diseases in an international context during the late nineteenth and early twentieth centuries.

Amalia Ribí Forclaz is currently a postdoctoral fellow at the University of Heidelberg. She wrote her DPhil thesis at Oxford on European anti-slavery organisations and their international campaign against slavery in East Africa between 1880 and 1940. Her current project examines the history of labour regulations in agriculture, particularly

the shifting terms in which European and non-European governments and pressure groups addressed the issue in international forums between the Great Depression and the Cold War.

Anna-Katharina Wöbse is a freelance environmental historian. She studied history in Bremen, Stockton-on-Tees and Bielefeld. Her research focuses on environmental diplomacy, the visual representation of the environmental movement and the genesis of the transnational civil society. Her dissertation, 'Weltnaturschutz: Umweltdiplomatie in Völkerbund und Vereinten Nationen, 1920–1950', will be published in 2011.

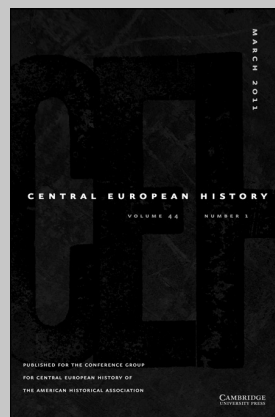

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short description of work in progress and previously published work
