## CONTRIBUTORS TO THIS ISSUE

RICHARD ABELS is Professor of History at the United States Naval Academy. He has published an article on female participation in the Cathar heresy in *Mediaeval Studies* (1979), and is writing a monograph on Anglo-Saxon military obligation and lordship.

P. W. J. BARTRIP is Senior Research Officer in Social History at the Centre for Socio-Legal Studies, Wolfson College, Oxford. He is the author of a number of articles on nineteenth-century British history and co-author (with S.B. Burman) of the forthcoming book, *The Wounded Soldiers of Industry. Industrial Compensation Policy, 1833-1897* (Oxford, 1983). Currently he is working on the history of workmen's compensation in the twentieth century as well as other aspects of the history of government regulation and social policy.

JUDITH M. BENNETT is Assistant Professor of History at the University of North Carolina at Chapel Hill. Her work on medieval village court rolls has produced studies on marriage licenses, commercial brewing, and social networks. At present she is completing a monograph on peasant women in pre-plague England.

GEORGE L. BERNSTEIN is Assistant Professor of History at Tulane University. His articles, "The Progressive Alliance in the Constituencies, 1900-1914: Three Case Studies," and "The Limitations of the New Liberalism: The Politics and Political Thought of John Clifford," will appear in the *Historical Journal* and *Albion*, respectively. He is working on a book on Liberal politics from 1899 to 1914.

WILLIAM J. BIRKEN received his doctorate in English History from the University of North Carolina at Chapel Hill. He is Library Assistant in the Standard Cataloguing Section of Wilson Library at that university. He is the author of "The Puritan connexions of Sir Edward Alston, President of the Royal College of Physicians 1655-1666," *Medical History* 18 (October, 1974), and "Dr. John King (1614-1681) and Dr. Assuerus Regemorter (1615-1650): Brethren in the Dutch Church and in the Royal College of Physicians in London, with added references to other 'Dutch' congregants in the Royal College, Dr. Baldwin Hamey and Dr. George Ent," *Medical History* 20 (July 1976). His current area of research remains seventeenth-century English physicians.

JOHN R. GREENAWAY is Lecturer in Politics at the University of East Anglia. He is co-author (with Richard A. Chapman) of *The Dynamics of Administrative Reform* (Croom Helm, 1980) and at present is researching for a book on "Interpretations of the British Political System 1850-1939."

PETER McCANDLESS is Associate Professor of History at the College of Charleston, South Carolina. Previous publications include “‘Build, build’: The Controversy over the Care of the Chronically Insane in England, 1855-1870,” *Bulletin of the History of Medicine*, 1979, and “Liberty and Lunacy: the Victorians and Wrongful Confinement,” in A. T. Scull, editor, *Madhouses, Mad-Doctors, and Madmen* (Philadelphia, 1981). He is working on a social history of insanity in South Carolina.
