This bilingual (English and Spanish) volume offers the first comprehensive study of Grupo Antillano, an Afro-Cuban visual arts and cultural movement that thrived between 1978 and 1983 and has been virtually erased from Cuban cultural and artistic history. Grupo Antillano articulated a vision of Cuban culture that underscored the importance of Africa and of Afro-Caribbean influences in the formation of the Cuban nation. They viewed Africa and the surrounding Caribbean as a vibrant, ongoing, and vital influence that continued to define what it meant to be Cuban. Some Afro-Cuban intellectuals proclaimed that a “new,” authentic Cuban art (radical, popular, black) had been born. This book seeks to recover and to honor that art.
