FRED BRONNER is senior lecturer in the Department of Spanish and Latin American Studies at the Hebrew University of Jerusalem. His research centers on the social history of colonial Peru.

SUSAN TIANO is Assistant Professor of Sociology at the University of New Mexico. She is currently studying the impact of industrialization on women in northern Mexico.
