## The Impact of the New World on the Old

*Edited by Fredi Chiappelli*

The discovery of America brought an avalanche of new phenomena to the Old World; strange peoples, customs, animals and plants never before imagined by contemporary Europeans.

There was a profound change in the perception of man and the contemporary world. The discovery shattered the myth of the world as a flat plane and confirmed the concept of the world as a sphere. This enlightenment contributed to man's awareness of the many spheres of the universe, and to his ultimate arrival on the moon. Ideas about the nature of man and of human society were challenged by the strange Amerindians. The European imagination developed the image of the "noble savage," and the writers of the day used it in the most varied ways—some to express a nostalgia for an innocent Golden Age, others to challenge the contemporary aristocratic society.

**FIRST IMAGES OF AMERICA: THE IMPACT OF THE NEW WORLD ON THE OLD** is the first comprehensive study dealing with the repercussions on Europe resulting from the discovery of the New World. The great impact on the lives and imaginations of the Europeans is analyzed by anthropologists, art historians, botanists, economists, geographers, historians, jurists, medical historians, philosophers, political scientists, literary specialists, linguists, and sociologists—all renowned scholars who converged to bring their varied expertise to bear on one of the most crucial moments in history.

The work consists of two massive volumes, 1,000 pages, with 138 illustrations, many in colour. The convergent character of the articles will offer readers insight into the relationship of different disciplines, such as politics and the arts, economics and theology. The introduction and widespread use in Europe of the New World tobacco, for example, provoked social, economic, medical, and legal repercussions.

Taking the study in its entirety, the reader is provided with a holistic view of the impact of the New World on the Old. The work will appeal to scholars and lay persons alike: rich bibliographies accompany each chapter, leading the adventurous reader to further scholarly investigations. Here is a monumental convergence of scholarship which will influence research for years to come. The original, collective approach to the study of the sudden enlargement of the physical and spiritual horizons of civilization is a significant contribution to all major fields, from art to warfare, from navigation to botany, from literature to anthropology.

**FIRST IMAGES OF AMERICA** stems from a conference organized in 1975 by the UCLA Center for Medieval and Renaissance Studies. The Center is one of the largest institutions of its kind, bringing together more than 120 scholars from 20 different disciplines to conduct research on problems of Medieval and Renaissance times, 600–1600 A.D.

# THE CONFLICT BETWEEN THE CALIFORNIA INDIAN AND WHITE CIVILIZATION

*Sherburne F. Cook*

This pioneering study of the interaction of two civilizations, the one old and static, the other new and dynamic, was originally published in several parts over a number of years in the *Ibero-Americana* monograph series. It has since gained fame as the most thorough account of the substantial disappearance of the Indian population of the middle Pacific Coast of the United States, and the utter extinction of its civilization under the influence of Spanish and American culture.

The volume provides a detailed description of the reaction of California Indians to the Spanish Mission system, to the civilian and military inroads, and to the American invasion after 1848. Also here are valuable analyses of trends in population, marriage and divorce, and of the extent of dietary adaptation among Indians in California and Nevada.

# THE POPULATION OF THE CALIFORNIA INDIANS 1769-1970

*Sherburne F. Cook*

The late S. F. Cook was involved in one of the great questions of New World history: How many Indians were there in the hemisphere when the Europeans first arrived, and at what rate and for what reason was that population reduced? His major aim in this volume, which consists of six original essays completed just before his death in 1974, was to provide a complete and final estimate of the native California population at the time of initial settlement in 1769. For this purpose he used every possible source of data, including records kept by the California missions and explorers' counts of village populations. The result is a significant upward revision of the estimated population: 310,000 as compared with A. L. Kroeber's estimate of 125,000 made fifty years ago.

Dr. Cook also examines the rapid decline in numbers (to less than 30,000 by 1865), and provides details of age distribution, birth and death rates, interbreeding with other races, and rural to urban migration up to present times.

### Biography of a City

*Edited by John and LaRee Caughey*

*Los Angeles: Biography of a City* is an anthology of some of the choicest writings on the city and its environments. Threaded historically these selections amount to a biography of this great metropolis, now approaching its 200th birthday.

Charting the steps in its transformation, the Caugheys evoke what it was like to be an Angeleno at the Spanish pueblo, in the pastoral interlude, when Los Angeles was a tough western cowtown, at the time of the coming of the automobile and the movie makers, under the pressure of World War II, and amid the perplexities and challenges of the present.

Writers drawn on include some who passed through quickly—Juan Rodriguez Cabrillo, Richard Henry Dana, William H. Brewer are examples; others for whom Los Angeles was a favorite subject—Horace Bell, Harris Newmark, Robert Glass Cleland, W. W. Robinson, Remi Nadeau, and Carey McWilliams; and others who at least once addressed themselves to this scene—Mary Austin, Joe Hill, Robinson Jeffers, Ralph Bunche, J. B. Priestley, and Earl Pomeroy. Ten of the selections are here published for the first time.

## AMERICAN FOLK MEDICINE

*Edited by Wayland D. Hand*

This book contains essays on a wide variety of subjects by twenty-five scholars in folklore and related fields, including *Schulmedizin*, folk medicine, medical botany, psychiatry, anthropology, and medical history. Investigations of the medical traditions of ethnic groups include the Pennsylvania Germans, the French of the St. Lawrence and Lower Mississippi River basins, the Hispanic and Latin-American peoples of Mexico and the Spanish Southwest, and the Negroes of Jamaica and the mainland. The medical practices of American Indians are explored in four papers, two of which are on shamanism.

Borne out in the essays are the convictions that the problems of folk medicine, whether encountered among primitives or in backward segments of the civilized community, involve the same essential elements: people seeking relief from pain and disease by any and all means at their disposal, including magical treatments as well as those prescribed under the rubric of natural medicine and empirical science.

He shows that the conquest produced more than a shift in international jurisdiction; it altered basic social, economic, and political conditions and laid the foundations for the tumultuous events that occurred at the close of the seventeenth century.

Van Deventer traces the developing economic and social structures of New Hampshire in the years from 1623 to 1741, before the boundary dispute with Massachusetts was settled and New Hampshire's land area tripled. He sees the colony as a model for understanding social development in the larger colonies.

Dealing first with the problems of apportioning and developing the land, the author examines the factors hindering the very survival of the settler—both the hostility of Indians and shortage of labor and capital. He then discusses the development of trade, especially the lumber trade, and shows how the province eventually supplanted the town as the dominant sociopolitical institution.

By focusing on three parishes—one Irish, one German, and one a mixed group of Germans and Irish—Dolan examines the role of religion in strengthening group life in these ethnic communities, traces the development of the church in the city, and reveals the relationship between urban and church growth.

### NOTES FOR CONTRIBUTORS

1. All contributions and editorial correspondence should be sent to: The Editor, *Journal of American Studies*, University of East Anglia, Norwich, NR4 7TJ, England.
2. Articles should generally contain about 5000 words. Longer or shorter articles, or articles in two or more parts, may be accepted by arrangement with the Editor.
3. Submission of an article is taken to imply that it has not previously been published, or is not being considered for publication elsewhere.
4. Contributions should be clearly typed in double spacing, preferably on A4 paper, with a wide left-hand margin. Diagrams and maps may be included by arrangement with the Editor.
5. Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered in one sequence throughout the article, and should preferably be typed in double spacing at the end of the article.
6. Contributors should keep one copy of the typescript for correcting proofs.
7. Notes intended for the Editor or printer should be on a separate sheet.
8. First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within ten days of receiving them.
9. Correction should be kept to an absolute minimum. It should be confined to errors of the typist or printer unless the Editor authorizes otherwise.
10. Contributors of articles and review articles receive 25 free separates. Extra copies may be ordered according to the scale of charges.
11. Contributors need not be members of the British Association for American Studies. Unsolicited typescripts can only be returned to overseas contributors who send International Reply Coupons (not postage stamps).
12. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the U.S.A.
