**BAKER LIBRARY NEW EXHIBITION.** Baker Library Historical Collections, Harvard Business School, announces the opening of a new exhibition, “Buy Now, Pay Later: A History of Personal Credit.” The exhibit will run from October 22, 2010, through June 3, 2011, in the North Lobby of Baker Library, Bloomberg Center, Harvard Business School.

There is a myth of a lost golden age of economic virtue. Once upon a time, the story goes, people lived within their means and borrowed only under the direst of circumstances. Debt was shameful, and credit financed only “productive” purchases like homes or farm machinery. Although nostalgia seldom makes good history, writers have nevertheless mourned this lost age through the Roaring Twenties, the rise of the credit card in the 1960s, and the home mortgage boom and bust of 2005–08.

“Buy Now, Pay Later: A History of Personal Credit” demonstrates that while the instruments and institutions of twenty-first century credit—the installment plan, the credit card, and the home finance industry—are less than a century old, credit itself is as old as commerce.

The exhibition draws from Baker Library's Historical Collections materials to show how previous generations devised creative ways of lending and borrowing long before credit cards or mortgage-backed securities.

**EUROPEAN BUSINESS HISTORY ASSOCIATION CONFERENCE.** The European Business History Association annual conference will take place in Athens on August 24–26, 2011. The theme will be “Business, Finance and the State in Twentieth Century: European Comparisons in Historical Perspective: Crises and Transformation.”

The theme of the conference refers to the debate and discussion of economic crises and recessions in the twentieth century, stimulated by the onslaught of the first severe recession of the twenty-first century. The contradictions of globalization have set in motion a process of introspection and questioning about the role of business, finance, and the state and a need to study the past, rethink concepts and processes, find keys to understanding the present, and work toward a solution for the future. The conference will focus on how crises have affected and created challenges for different types of business, especially, but not only, during the twentieth century.

**ECONOMIC HISTORY ASSOCIATION CONFERENCE.** The annual meeting of the Economic History Association, focusing on the theme of “Crises and Turning Points,” will take place in Boston, Massachusetts on September 9–11, 2011.

This conference seeks to bring together scholars engaged in research on the various dimensions of crises and their implications. Graduate students are encouraged to attend the meeting. The Association offers subsidies for travel, hotel, registration, and meals, including a special graduate student dinner. A poster session welcomes work from

dissertations in progress. Applications for the poster session are due no later than May 21, 2011, and should be sent to grossman@wesleyan.edu. The dissertation session convened by Kris James Mitchener (Santa Clara University) and Brian Ahearn (University of Oxford) will honor six dissertations completed during the 2010–11 academic year. The submission deadline is June 11, 2011. The Alexander Gerschenkron and Allan Nevins prizes will be awarded to the best dissertations on non-North American and North American topics respectively.

**INSTITUTE FOR HISTORICAL STUDIES FELLOWSHIPS.** The University of Texas at Austin Institute for Historical Studies offers fellowships for both professors and postdoctoral and independent scholars. Fellowships for tenure-track and tenured faculty will provide stipends equal to half salary up to \$50,000 per year, and are available for the year or (prorated) for the semester. Applicants may combine IHS fellowships with sabbatical funds, other support from their home institutions, or external grants. (Total funds may not exceed annual salary for the year of the fellowship.)

Please note that the IHS will not provide medical insurance for tenure-track or tenured faculty, and applicants are required to make appropriate individual arrangements with their home institutions.

Fellowships for postdoctoral and independent scholars will provide salaries of \$40,000 per year and medical insurance. These fellowships are also available prorated for the semester. Junior fellows must have PhDs in hand no later than March 31, 2011.

**GILDER LEHRMAN INSTITUTE FELLOWSHIPS.** The Gilder Lehrman Institute awards short-term research fellowships to scholars working in American history at every level from doctoral candidates to senior faculty, including independent scholars. Ten fellowships are awarded each

year. The fellowships support research within American history archives in New York City. Doctoral candidates, postdoctoral scholars, college and university faculty at every rank, and independent scholars are eligible. For 2011–12, ten Gilder Lehrman Fellowships of \$3,000 will be awarded. Fellows must complete their research within a year of notification of the award.

To apply, candidates should submit:

- A proposal describing the project, the nature of the archives to be consulted, an anticipated budget of expenses, and full contact details
- A curriculum vitae
- Two letters of recommendation from established scholars

Applications must be postmarked or submitted via e-mail by May 1, 2011. Application materials should be sent to:

LIBRARY COMPANY OF PHILADELPHIA FELLOWSHIPS. The Library Company of Philadelphia and the Historical Society of Pennsylvania will jointly award approximately twenty-five one-month fellowships for research in residence in either or both collections during the academic year 2011–12. These two independent research libraries, adjacent to each other in Center City, Philadelphia, have complementary collections capable of supporting research in a variety of fields and disciplines relating to the history of America and the Atlantic world from the seventeenth through the nineteenth centuries, as well as Mid-Atlantic regional history to the present.

The stipend for a short-term fellowship is \$2,000. Fellowships are tenable for any one-month period between June 2011 and May 2012. They support advanced, postdoctoral, and dissertation research. Candidates are strongly encouraged to inquire about the appropriateness of the proposed topic.

The deadline for receipt of one-month fellowship applications is March 1, 2011, and a decision must be made by April 15.
