W. K. Kellogg was one of several business leaders in the 1930s who thought that the answer to unemployment lay in shorter hours. Indeed, the company's management in that period believed that technological advances would make increasing leisure inevitable, and Kellogg himself devoted a good deal of his fortune to providing recreational sites and programs for his workers, anticipating the growth of free time generated, in part, by the company's six-hour day. The company band, shown on our front cover assembled on the steps of the Kellogg's plant in Battle Creek, Michigan, was one of the dozens of employee activities that W. K. Kellogg encouraged.

The paternalistic bent evident in W. K. Kellogg's programs meshed with a clever advertising initiative when he determined to distinguish his cereal—originally called Sanitas Toasted Corn Flakes—from those of its many imitators by creating a logo of his written name and the phrase "The Original Bears This Signature." Benjamin Kline Hunnicutt is professor at the University of Iowa and the author of Work Without End: Abandoning Shorter Hours for the Right to Work (1988). He received his Ph.D. in history from the University of North Carolina, Chapel Hill, and he has been active in the shorter-hours movement in the United States. He is currently the co-director of the Society for the Reduction of Human Labor and co-editor of its newsletter. He is finishing a book on Kellogg's and Battle Creek workers.

Allen Kaufman is chairman of the Department of Management at the University of New Hampshire's Whittemore School of Business and Economics. He has written extensively on business-government relations with articles in numerous academic journals, and he is the co-author of The End of Managerial Ideology: Managerial Collective Action and the Regulatory State, 1920–1980 (forthcoming from Oxford University Press, 1994). His current research considers how public policy initiatives may help small and medium-size enterprises compete in global markets. He has been pursuing these questions as a research fellow at the Center for Business and Government of the John F. Kennedy School of Government at Harvard University, as co-director of the Whittemore School's Center for Business and Economic Research, and as co-executive director of the Governor's Technology Partnership for New Hampshire.

Mark Mason is assistant professor of management at Yale University's School of Organization and Management. He holds a B.A. from Haverford College and a Ph.D. from Harvard University. He has written extensively on international business-government relations and has published in a number of academic journals. His past research analyzed the political economy of U.S. foreign direct investment (FDI) in Japan, and he is currently examining the political economy of Japanese FDI in the European automobile, banking, and consumer electronics industries. Recent and forthcoming publications include American Multinationals and Japan: The Political Economy of Japanese Capital Controls, 1899–1980

(1992) and Does Ownership Matter? Japanese Multinationals in Europe (forthcoming), co-edited with Dennis Encarnation.

Lawrence Zacharias is associate professor in the School of Management at the University of Massachusetts, Amherst. He has published articles on the history and theory of the corporation, and he is the co-author (with Allen Kaufman and Marvin Karson) of The End of Managerial Ideology (forthcoming from Oxford University Press). He is currently working on a series of historical essays relating legal to technological development in the United States.
