LABOR PRODUCTIVITY IN SOVIET AND AMERICAN INDUSTRY

The continued growth of Soviet industry depends in large part on whether output per man can be increased in the future as it has been in the past. Here for the first time is a careful analysis of how the efficiency of the Soviet worker measures up to that of his American counterpart. Discussed are the productivity concepts employed and the problems involved in statistical comparisons. A careful analysis is made of the significance and the limitations of the productivity concept, of Soviet statistics and their comparability with American statistics. Industries represented with figures on productivity in the two countries include extractive, heavy manufacturing, and consumer goods. Much of the information comes from Soviet technical journals not fully exploited before.

LAW AND MORALITY: LEON PETRAZHITSKY

Translated by HUGH W. BABB, with an Introduction by N. S. TIMASHEFF. Petrazhitsky's thought is here made available in English for the first time in a translated and abridged presentation of his two major works. Petrazhitsky sees law not primarily as the rules or norms enforced by the state, but rather as the consciousness of rights and duties which exist in the minds of men; and he reaches the striking conclusion that the chief end of law is to educate men in the spirit of active love for their neighbors. He explains what law is in a manner which gives it a new significance not only for lawyers but also for sociologists, theologians, and others who are concerned with the specific characteristics which differentiate the legal order from other aspects of life. *20th Century Legal Philosophy Series.*

BOOKS IN RUSSIAN

*Standing for the Freedom of Speech and
Produced in a Free Country*

Mark Aldanov—NIGHT AT ULM 348 pp. \$2.75

Using the form of a dialogue, Aldanov presents a penetrating analysis of fundamental problems of culture, politics and philosophy. Of unusual interest is the question, posed by the author, concerning the role of chance and regularity in history, with reference to such events as the October Revolution.

Maria Bock—MY FATHER, PETER STOLYPIN 347 pp. \$2.75

The name of Peter Stolypin is associated with a period of remarkable reforms at the beginning of the 20th century. Up to now, however, very little has been written about Stolypin the man. In this simply written book, the author, Stolypin's daughter, has depicted Stolypin as a man who was at the same time an exemplary manager of his estate, a brilliant administrator, and an outstanding political figure.

Victor Chernov—BEFORE THE STORM 412 pp. \$3.00

Compiled in book form after his death, these memoirs of one of the leaders of the Social Revolutionary Party depict the growth of the revolutionary movement in Russia, its victory in February 1917, and the defeat of the democratic revolution by the Bolsheviks under the leadership of Lenin.

Anton Denikin—THE ROAD OF A RUSSIAN OFFICER 382 pp. \$2.75

In this book, General Denikin tells of his life in the years before the Civil War. Written with the simplicity, sincerity and directness which always distinguished this White Russian leader, these memoirs reveal the great literary talent of their famous author.

Alexis Goldenweiser—IN DEFENSE OF THE LAW 267 pp. \$3.00

Law and the courts of pre-Revolutionary Russia form the central theme of this volume by Alexis Goldenweiser. This is a rather special subject, but Mr. Goldenweiser displays such a breadth of vision in his approach to the problem of law that his book will capture the attention of every reader interested in the fortunes of the Russian people.

Gleb Struve, Editor—THE UNPUBLISHED GUMILYOV 237 pp. \$2.25

This collection contains a number of Gumilyov's unpublished work, a play, "The Poisoned Tunic," an unfinished novelette, "Gay Brothers," a number of poems and an essay on the theory of poetry.
