prose saints' Lives, reveals the unpredictable but fascinating concerns of Anglo-Saxon translators. A pioneering study of the 'Solomon and Saturn' dialogues throws new light on their later sources and associates them convincingly with King Alfred's reinvention of English learning. A thorough analysis of the lexical range of OE *craft* in the prose *Boethius* helps to illustrate many of King Alfred's intellectual concerns.

The fields of palaeography and liturgy – which in recent years have profited from increasing attention – are also importantly represented here. New precision is brought to the classification and dating of ninth-century set and cursive minuscule script. The study of ninth-century liturgical books from Echternach permits reasonable inferences about the English origins of the liturgy brought to the Continent by Echternach's founder, the Northumbrian bishop Willibrord, and throws new light on the liturgy in use in England during the first century of the English church.

The volume includes the invaluable annual bibliography, providing a comprehensive listing of 1996 publications in all branches of Anglo-Saxon studies.

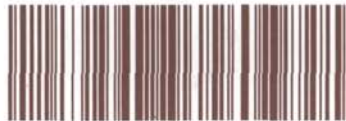
