M. Gerard Fromm is the Evelyn Stefansson Nef Director of the Erik H. Erikson Institute for Education and Research of the Austen Riggs Center in Stockbridge, Massachusetts. In this role, he leads the Center's effort to bring its clinical learning into dialogue with related disciplines and the problems of the larger society. He is also a psychotherapist, a supervisor of psychotherapy and a seminar leader at Austen Riggs, and for many years was the Director of its Therapeutic Community Program. Dr Fromm is certified as a psychoanalyst by the American Board of Professional Psychology and is on the faculty of the Massachusetts Institute for Psychoanalysis and the visiting faculty of the Psychoanalytic Institute of Northern California. Richard N. Frye is Emeritus Professor of Iranian in the Department of Near Eastern Languages and Literature at Harvard University. He is a specialist in Oriental, in particular Iranian, history. After studying philosophy he obtained a doctorate in history from Harvard and simultaneously learnt Turkish, Persian, Avestan and Sogdian, as well as many other Oriental languages. He taught at Harvard and the Universities of Frankfurt, Hamburg and Tajikistan, was director of the Asia Institute at the Pahlavi University in Shiraz, Iran, and was the guest of the Hermitage Museum in St Petersburg. Among his many publications are: *Notes on the Early Coinage of Central Asia*; *History of the Nation of the Archers*; *The United States & Turkey & Iran*, with L. Milton Glaser an artist and designer, studied at the High School of Music and Art, New York (1944–7); the Cooper Union Art School, New York (1948–51), and later the

Academy of Fine Arts in Bologna, Italy (1952–3). In 1954 he created the Pushpin Studios with friends, and with Seymour Chwast he directed the studios for 20 years. In 1968 Glaser and Clay Felker started the *New York Magazine*, which became a model for other magazines. In 1983, with Walter Bernard, Glaser created the design publication office WBMG, which helped to update the design of: *L'Espresso* (Rome), the *Journal of Art*, de Rizzoli, *Magazine Week*, *The Washington Post*, *La Vanguardia* (Barcelona), *Manhattan, Inc.*, *Family Circle*, *Adweek*, *U.S. News*, *The New York Law Journal*, *Fortune*, *Barron's*, *Lire*, *The Village Voice*, *Jardin des Modes*, *Modern Maturity*, *Money and The Nation*, etc. Milton Glaser, Inc. came into being in 1974. Glaser has been personally responsible for the design and illustration for more than 300 posters in the areas of publishing, music, theatre, cinema, etc. He is also the creator of the most imitated logo in the world: I♥NY, which was commissioned by New York State in 1976. Gay McDougall Since September 1994, Gay McDougall has been Executive Director of the Washington-based International Human Rights Law Group, a non-profit organization engaged in human rights advocacy, litigation and training around the world. She has recently been awarded a coveted MacArthur Foundation Fellowship for her 'innovative and highly effective' work on behalf of international human rights. In 1994, she served as a member of South Africa's Independent Electoral Commission that ran the first non-racial elections in that country. From 1997 to 2001 she served on the United Nations treaty body that oversees implementation of the International Convention on the Elimination of All Forms of Racial Discrimination. She was the first American to be elected to the body of 18 international experts who oversee compliance by governments worldwide with the obligations established under the treaty.
