

*Behavioral Archeology* is a methodological study of broad scope, covering the nature of archeological remains and the ways of reconstructing past human behavior from those remains. Its primary emphasis concerns the need for formulating, testing, and employing archeological laws. The book demonstrates how the diverse activities of modern archeology, such as experimentation, ethnoarcheology, computer simulations, modern garbage studies, and more traditional interests, fit together into a coherent enterprise bound by the pursuit and use of general principles. The author has applied his general framework, to the study of chipped-stone artifacts from the Joint Site, a Pueblo III ruin in eastern Arizona.

This book offers significant new insight into the economic behavior of hunters and gatherers. The author approaches the study of prehistoric artifacts by means of a predictive model based on archeological as well as ethnographic data. This unique model—representative of contemporary anthropological views—constitutes a number of explicit assumptions founded upon observed regularities among diverse ethnographic groups. From its construction evolves a useful set of predictions about the nature of a hunting and gathering economy in a particular environment. Applying his model to various ethnographic groups with considerable success, the author demonstrates the widespread implications this model will generate for the archeological record.

This book is written for archaeologists at all levels—students, research workers, teachers and field archaeologists. Dr. Limbrey explains the processes that go on in soils, how these affect the preservation of materials in the soil, and how they result in the development of characteristic soil profiles. Soil profiles and their distribution can be linked to other environmental factors, both natural and man-influenced. Some British soils, which have been strongly influenced in their development by man's activities, are considered in detail. This is a rapidly developing field of study and a fertile area of cooperation between soil scientists and archaeologists. Soils of other parts of the world are reviewed. The final section of the book is designed to meet the field archaeologists need for guidance in surveying, describing, and interpreting soils and sediments as met with in excavations.
