He is a professor and researcher in the professional masters course in political science maintained by the Chamber of Deputies of Brazil. JEAN-PHILIPPE BELLEAU is an assistant professor in the Latin American and Iberian Studies Department at the University of Massachusetts at Boston and an associate researcher at the Centro de Estudos de Migrações Internacionais at the University of Campinas, São Paulo, Brazil. He is the author or coauthor of *Vidas vulnerables: Migración, derechos humanos y políticas públicas en cinco zonas fronterizas de América Latina* (2013), *La frontera doliente: Migración, género y salud en la región México-Guatemala* (2013), and *Vivir del norte: Remesas, desarrollo y pobreza en México* (2008). American Population Review. Currently he is a member of CONACYT's National System of Researchers and the Mexican Academy of Sciences.

MIGUEL CENTELLAS is an assistant professor of political science at Jackson State University. His research is on electoral politics and democratic institutions, with a special focus on Bolivia. His most recent article, "The Democracy Cluster Classification Index" (coauthored with Mihaiela Ristei Gugu), appeared in *Political Analysis*.

PATRICIA B. CHRISTIAN is associate professor of sociology at Canisius College, Buffalo, New York. She is a demographer with interests in family, gender, and religion. She is part of a team that has administered and is analyzing several surveys exploring the rise of Evangelical and Pentecostal religion in El Salvador. She has traveled with her collaborators to El Salvador and the Philippines through the Institute for the Global Study of Religion at Canisius College, looking at the rise of Evangelical and Pentecostal denominations and the Catholic response.

MICHAEL GENT is professor of organization studies at Canisius College in Buffalo, New York. He has published articles in *Delaware Review of Latin American Studies*, *Organization Management Journal*, and the international Jesuit publication *Promotio Iustitiae*. He recently coauthored a chapter in *De las misiones de fe al neopentecostalismo: Génesis y evolución del protestantismo salvadoreño, desde el siglo XIX hasta el presente*, published by the Salvadoran Secretary of Culture. His current research interests include neoliberal policies and reactions to neoliberalism in Latin America, as well as the organizational structure and development of Latin American Pentecostal churches.

MATTHEW C. INGRAM is an assistant professor in the Department of Political Science, University at Albany, State University of New York, where he is also a research associate at the Center for Social and Demographic Analysis. His research examines justice reforms, judicial behavior, and violence in Latin America. He holds a JD (2006) and a PhD in political science (2009), both from the University of New Mexico. His work has appeared in *Comparative Politics*, *Journal of Law, Economics, and Organization*, and *Government and Opposition*, as well as in various edited volumes and policy reports.

PETER TAYLOR KLEIN is an assistant professor of sociology and environmental and urban studies at Bard College. Broadly, his work focuses on development, associational life, relations between the state and civil society, and environmental conflicts in both Brazil and the United States. He is working on a project that examines local contestations around the construction of the Belo Monte hydroelectric facility in the Brazilian Amazon. In addition to publishing articles in journals including *American Journal of Sociology* and *Teaching Sociology*, he is also a coauthor of the book *The Civic Imagination: Making a Difference in American Political Life* (2014).
