Jean-Godefroy Bidima, professor, holds the Yvonne Arnoult Chair at Tulane University, USA, was programme director at the Collège International de Philosophie and is associate researcher in the Centre d'Études Africaines at the École des Hautes Études en Sciences Sociales, Paris. His research deals with philosophy, art and the imaginary in Africa, problems related to argumentation in anthropological, legal and historical discourse on Africa and normative and ethical assumptions in the different discourses on disease in Africa. He is the author of *La Palabre: une juridiction de la parole* (1997), *L'Art négro-africain* (1997), *La Philosophie négro-africaine* (1995) and *Théorie critique et modernité négro-africaine: de l'École de Francfort à la 'Docta spes africana'* (1993).

Tanella Boni (Ivory Coast), poet, philosopher, novelist and art critic, is a tenured professor at the University of Abidjan. She was a member of the committee for the network 'État de droit saisi par la philosophie' of the Agence Universitaire de la Francophonie (2001–4) and vice-president of the International Council for Philosophy and Humanistic Studies. Among her recent publications are 'Lettre aux générations futures' (UNESCO, 1999) and the novels: *Matins de couvre-feu* (Ahmadou Kourouma Prize 2005) and *Les Nègres n'iront jamais au paradis* (2006). Her most recent publication is *Que vivent les femmes d'Afrique?* (2008).

Laurence Cornu (France) is lecturer in philosophy at the IUFM and head of the philosophy department and the department of human sciences for education at the IUFM, Poitou-Charentes. She is a member of the Laboratoire d'Études et de Recherches sur les Logiques Contemporaines de la Philosophie at the University of Paris 8. Kathia Martin-Chenut (France-Brazil) holds a doctorate in law from the University of Paris I (Panthéon-Sorbonne). She is associated with the Chair in Comparative legal studies and internationalization of law at the Collège de France and coordinates the Franco-Brazilian Network for the Internationalization of Law. Among the topics studied are: use of amnesty, acquittal or limitation in cases of grave violation of human rights; exercise of justice by military jurisdictions; reparation for violations of human rights; internationalization of children's rights and criminal policies applied to juvenile delinquency.

Gloria López Morales (Mexico), a specialist in the management of culture and the issues raised by cultural pluralism, cultural specificity and development, has participated in programming UNESCO activities, coordinated events around the 500th anniversary of the Meeting of Two Worlds (Europe/America), headed the UNESCO bureau in Havana (Cuba), and is author of various works on culture as well as of books on political issues.

Françoise Rivière (France), an alumna of the École Normale Supérieure, holds an *agrégation* in classics and a degree from the Institut d'Études Politiques in Paris. She lectured at Yale University (USA) in 1974, then at the University of Paris-Val de Marne. Joining UNESCO in 1981, she occupied various positions in the Director-General's office before taking charge of the Bureau d'Études, de Programmation et d'Évaluation, with the rank of Assistant Director-General. In November 1999 she was appointed executive director of the UNESCO Director-General's office and in May 2006 Assistant Director-General for culture.

Sérgio Paulo Rouanet (Brazil), essayist and diplomat, professor at the University of Brasilia and former Minister of Culture for his country, developed the law bearing his name that encourages investment in culture. His books include *Édipo e o anjo. Itinerários freudianos em Walter Benjamin* (1981), *A razão cativa* (1985), *Teoria crítica e psicanálise* (1983), *As razões do Iluminismo* (1987), *O espectador noturno. A Revolução Francesa através de Rétif de la Bretonne* (1988), *Mal-Estar na Modernidade* (2001), *Os dez amigos de Freud* (2 volumes, 2003), *Riso e melancolia* (2007). He is a member of the Brazilian Academy of Letters, the Brazilian Academy of Philosophy and the Historical and Geographical Institute of Brazil.

Vincent Shen (Canada), holder of Lee Chair in Chinese Thought and Culture, Department of East Asian Studies and Department of Philosophy; and Chair, Department of East Asian Studies, University of Toronto, has published *Désenchantement du monde: l'impact de la science et de la technologie sur la culture* (1984), *After Physics – The Development of Metaphysics* (1987), *A Philosopher's Diagnosis of Modern Civilization* (1985), *Technology, Human Values and Postmodernism* (1990), *Rebirth of Tradition* (1992), *Confucianism, Taoism and Constructive Realism* (1994), *Contrast, Strangification and Dialogue* (2002), *Technology and Culture* (2003), *Generosity to the Other* (2004), *Idea of University and Spirit of Strangification* (2004), *An Anthology of Vincent Shen* (2005).

Michèle Therrien (France) is a field researcher in Nunavut and Nunavik, university lecturer, director of courses in Inuit languages and cultures and director for the *Parole* programme of a doctoral induction team at the Institut National des Langues et Civilisations Orientales (INALCO). She is the author of *Printemps Inuit, Naissance du Nunavut* (1999), a reflection on Inuit political strategy which led to the creation of a third territory in Canada.
