TIKAL REPORTS

Publication of the important excavation of Tikal continues with two more in the projected total of thirty-nine reports.

TIKAL REPORT No. 13 *The Settlement Survey of Tikal*
Dennis E. Puleston (William A. Haviland, volume editor)

In any future discussion of Classic Maya settlement, this unprecedented work will be the standard reference volume. Maps (1:5000) of four cardinal oriented strips, each a half-kilometer in width and extending twelve kilometers from central Tikal, document the survey area. In addition to these major maps, a number of 1:2000 maps cover the many relatively small sites, such as Uoluntun, Chikin Tikal, and El Encanto, that are believed to be subsidiary to Tikal. The accompanying text explains the strategy, procedures, and theoretical considerations of the mapping program.

It is suggested that Report No. 13 be used in conjunction with the maps of central Tikal, published in the still available Report No. 11, for the most comprehensive overview of Tikal and its environs.

TIKAL REPORT No. 31 *The Graffiti of Tikal* Helen W. Trik and Michael E. Kampen (William R. Coe, volume editor)

The graffiti incised on walls and other surfaces at Tikal afford an important and fascinating glimpse into a little explored area of Classic Maya life. This wealth of figural and symbolic material was produced by the inhabitants of Tikal over a span of perhaps fifteen hundred years. The entire methodically recorded corpus (as of 1970), from elegantly drawn personages to simple hand prints, is illustrated in linework at a common scale of 1:8. The text deals with the recording, fidelity, technical variety, and locational range of graffiti in time and space. Brief note is made of basic interpretative issues raised by this graffiti.

QUIRIGUA REPORTS

From 1973 to 1979, The University Museum conducted investigations at this major lowland Maya site in the lower Motagua Valley of eastern Guatemala. The Quirigua Project's objectives included the testing of hypotheses concerning the origins, location, functions and demise of Quirigua. The second in a series of seven reports, each consisting of a number of papers of specific aspects of the work, is now available.

QUIRIGUA REPORTS: II, Papers 6-15 Edward Schortman and Patricia Urban, editors. This volume contains summaries of the final seasons of research [1977-1979]. Of vital importance to Maya scholars is the first description of Quirigua's newly discovered stela, Monument 26, by Christopher Jones, with drawings by Carl P. Beetz. The Report also includes: the first detailed drawings of two of the finest Maya sculptures, Monuments 23 and 24 (Altars of Zoomorphs O and P), rendered by William R. Coe, a comparison of Quirigua and Copan sculptural styles, by Arthur G. Miller; Payson D. Sheets's study of obsidian technology at Quirigua; a description of the magnetometer survey of the site, by Bruce Bevan; a second consideration of lichen control, by Mason Hale; and a report on the 1976 earthquake at Quirigua, by Robert J. Sharer and Bruce Bevan.
