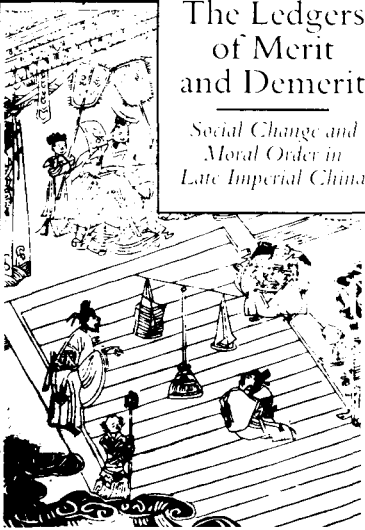

The ledgers of merit and demerit were a type of morality book that achieved sudden and widespread popularity in China during the sixteenth and seventeenth centuries. Consisting of lists of good and bad deeds, each assigned a certain number of merit or demerit points, the ledgers offered the hope of divine reward to users "good" enough to accumulate a substantial sum of merits. By examining the uses of the ledgers during the late Ming and early Qing periods, Cynthia Brokaw throws new light on the intellectual and social history of the late imperial era.

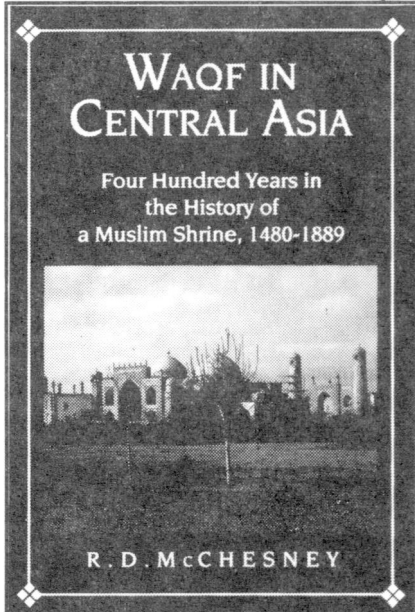

R. D. McChesney focuses on the major Muslim shrine at Balkh and provides a detailed study of the political, economic, and social conditions that influenced, and were influenced by, the development of a single religious endowment.

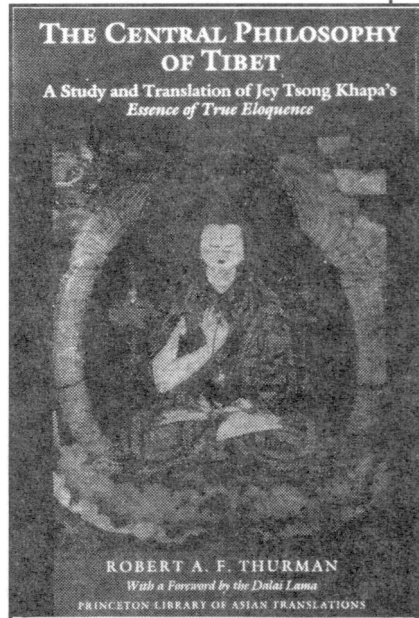

The Department of Chinese provides teaching in a wide range of courses in Chinese studies. The courses lead to the B.A., M.A., M.Phil. and Ph.D. degree. The Department's interests are the study of Chinese Language and Literature, Chinese History, Chinese Philosophy and Translation. Applicants should be able to teach two or more courses at both the undergraduate and postgraduate levels. They should also have substantial research experience and academic publications, and experience in the supervision and development of higher degree programmes.

The University would prefer to make a permanent appointment, but consideration may also be given to applications for appointment on fixed or secondment terms of preferably not less than three academic years. The University reserves the right not to fill the Chair or to fill the Chair by invitation or to make an appointment at a lower level.

Annual salary [superannuable] will be within the professorial range, of which the minimum is HK\$620,880 and the average is HK\$768,000 (approx. £41,390 and £51,200 respectively; sterling equivalent as at February 28, 1991). Leave and medical benefits will be provided. Depending on the type of contract offered, other benefits may include: provident fund benefits or an end-of-contract gratuity, a settling-in allowance of S\$1,000 or S\$2,000, subsidised housing at nominal rentals ranging from S\$100 to S\$216 p.m., education allowance for up to three children subject to a maximum of S\$10,000 per annum per child, passage assistance and baggage allowance for the transportation of personal effects to Singapore. Staff members may undertake consultation work, subject to the approval of the University, and retain consultation fees up to a maximum of 60% of their gross annual emoluments in a calendar year.

The Department of Chinese Studies is a department in the Faculty of Arts and Social Sciences. There are 8 faculties in the National University of Singapore with a current student enrolment of some 15,000. All departments are well-equipped with a wide range of facilities for teaching and research.
