BLOOD GROUPS AND DISEASES

A Study of Associations of Diseases with Blood Groups and Other Polymorphisms

By A.E. Mourant, A.C. Kopeć and K. Domaniewska-Sobczac (London, U.K.). Oxford University Press, Oxford 1978. Hard cover with jacket,  $28.5 \times 22.5$  cm, 1X + 328 pp. Price: £ 25.

A sequel to *The Distribution of the Human Blood Groups and Other Polymorphisms*, recently published by the same authors in the same monumental series of the Oxford Monographs on Medical Genetics, *Blood Groups and Diseases* provides a vast body of data on the associations of diseases with blood groups and other polymorphisms. Over 1,000 publications have been analyzed and their results tabulated, statistically treated and interpreted.

The volume is subdivided into two main parts: a series of descriptive chapters and a series of tables. The first part is introduced by two chapters, one general and one devoted to the genetics, biochemistry and serology of the various polymorphisms under examination. Specific chapters then follow, describing the associations found in a variety of conditions, such as neoplastic diseases, disorders related to pregnancy, peptic ulcers, diabetes mellitus, rheumatic fever and rheumatic heart disease, diseases of the circulatory system, etc. The descriptive part is completed by an account of the phenylthiocarbamide tasting system, the  $\alpha_1$  protease inhibitor system, and the histocompatibility antigens.

The second part consists in a series of tables where the results of about 1,000 studies observing given polymorphisms in a variety of diseases are reported. For each study, the place of observation, the bibliographic reference, the absolute and relative frequencies, and a  $\chi^2$  analysis, are reported. The detailed tables on the ABO, MN, Rh blood group systems, the ABH secretor, plasma haptoglobin, and PTC tasting systems, are followed by very useful tabular summaries.

The volume is completed by an Appendix on the associations between HLA and disease, reproduced from the original report from the HLA and Disease Registry of Copenhagen (L.P. Rydes et al. 1976).

Because of the rapid advances in the field, Dr. Mourant may well be right in concluding that "new and perhaps very different editions will be needed in the coming years". Nevertheless, there seems to be little doubt that *Blood Groups and Diseases* will prove an invaluable piece of reference not only to the specialist but more generally to the human biologist.

HEALTH AND THE HUNTER-GATHERER

Biomedical Studies on the Hunting and Gathering Populations of Southern Africa.

A valuable addition to Karger's series of Monographs in Human Genetics, this nice booklet provides a detailed description of the biological status of the hunting and gathering populations of Southern Africa. These consist of a variety of groups, among which the two major ones, Khoisian (Bushmen and Hottentots) and Negro, not all of whom biologically interrelated. In fact, even though most of them speak the same (Khoisian) language, there appears to be little evidence of gene exchange among these The booklet is subdivided into the populations. following main sections: (1) The Southern African deserts and their inhabitants, (2) The physical characters of the Southern African hunter-gatherers, (3) The medical relevance of the genetic polymorphisms, (4) Polymorphisms of no known medical relevance, (5) Adaptation to the environment, (6) Population structure among the Southern African hunter-gatherers.

Proceedings of the 1977 Biochemistry Society's Colloquium, devoted to DNA integration and including a variety of contributions dealing with topics such as gene control in the Imbda repressor, integrations of bacteriophage lambda in DNA recombinant research, integration of bacteriophage Mu. ISelements, tumor viruses and viral integration, viral and chemical carcinogenesis, tumor formation in plants, and related subjects.

## THE HLA SYSTEM

Edited by W.F. Bodmer (Oxford, U.K.). Vol. 34 No. 3 of the British Medical Bulletin, London 1978. 112 pp, illustrated. Price: £ 5 (outside U.K. £ 6).

This issue of the British Medical Bulletin provides a general review of the HLA system in all its various aspects. A number of contributions are devoted to the definition and function of the HLA loci, their genetics and biochemistry. However, the general emphasis is on the clinical applications, especially in the field of transplantation and of the associations between HLA system and disease.

BONE DYSPLASIAS OF INFANCY

A Radiological Atlas

By B.J. Cremin and P. Beighton (Cape Town, South Africa). Springer-Verlag, Berlin-Heidelberg 1978. Hard cover, 28 × 20 cm, XIII + 109 pp, 124 illustrations. Subject index. Price: DM 78, US \$ 39.00.

A combination of systematic assessment of the radiological evidence and the genetic characteristics of the bone dysplasias of infancy, such as achondrogenesis, thanatophoric dysplasia, asphyxiating thoracic dysplasia, chondroectodermal dysplasia, lethal short rib-polydactyly syndromes, chondrodysplasia punctata, camptomelic dysplasia achondroplasia, diastrophic dysplasia, metatropic dysplasia, spondyloepiphyseal dysplasia congenita, mesomelic dysplasia, Larsen syndrome, cleido-cranial dysplasia, osteogenesis imperfecta congenita, hypophosphatasia, osteoporosis, and other sclerosing bone dysplasias.

The atlas is completed by a glossary of useful terms, some comments on terminology, and general notes on the clinical and genetic evaluation of the neonate with skeletal dysplasia, as well as on radiographic techniques.

A beautifully designed and beautifully produced, authoritative handbook, consisting of eleven well-organized chapters, respectively devoted to: the bone marrow, the erythrocyte, the granulocyte, the monocyte, the lymphatic system, the complement, leukemias, malignant lymphomas, hemostasis, hematology of newborn, and hematologic troubles and organic diseases. A very detailed index completes this precious volume.
