# XIXth GENERAL ASSEMBLY FIRST SESSION

Held in the Siri Fort Auditorium 19th November 1985, 15:30

Prof. R. Hanbury Brown, President in the Chair

## Opening of the First Session

Before we go any further I want to say just a few words to the many people in this Hall for whom these proceedings are their first experience of an IAU meeting. I am concerned that much of the Agenda may seem to them not only boring but unnecessary. I shall not try to persuade them that these proceedings are entertaining, but only that they are necessary. The IAU, thanks to a lot of hard work by few dedicated people, can justifiably claim to have the least possible administrative machinery at the least possible cost. The agenda of this session represents the essential nuts and bolts of that machinery.

I have in mind an awful picture of some newcomers to our Union trying to find out what the IAU is all about by reading our Transactions Volume B in their library before setting out for the General Assembly. Our Statutes would tell them the purposes of this Union, but only in the most general terms; however if they were lucky enough to come across the recent Report of the Subcommittee on IAU Commission Structure, to which I shall refer later, then they would find the functions of this Union spelled out more in terms of what it actually tries to do.

Very briefly the principal aim of the Union, a very worthy aim, is to develop astronomy through international cooperation. In pursuit of that aim it sponsors international scientific meetings, international scientific programmes, international scientific services which are needed by astronomers, and it represents the interests of astronomy on a host of international bodies. If you cannot always see how these functions are related to what is going on in this meeting, then there is one major function of our Union which you can appreciate quite simply by looking aroud the hall. I refer, of course, to the fact that the IAU promotes international cooperation in astronomy by fostering an international community and by encouraging an awareness of that community. In a world which is divided by nationalism the IAU aims to preserve the unity of astronomy with the other sciences. One of the principal ways in which it does so, is to create a community of people with a common interest in the one sky which we all share.

Let me remind you of just two of the many ways in which it does this: firstly, unlike many other international Unions, it enlists individuals as members: secondly, it spends a great deal of time, trouble and money in bringing these individuals together every three years. And so I ask you to remember that this General Assembly, with all the inevitable difficulties which attend any large meeting, is not to be seen simply as a number of smaller meetings of specialised Commissions, but as an important step towards one of the principal objectives of our Union, the making of a real, live, international community of astronomers.

One of the first things I did when I was elected President was to try to find out whether or not there was a need to reorganise the IAU either to meet its present obligations or to meet those of the future. I asked the opinion of a great many people, Presidents of Commissions, past Officers of the Union and so on. To my surprise and dismay, very few people were prepared to make serious criticisms of the Union; all they had to offer were minor improvements. It seemed that either the Union was perfect or, perhaps, that it was beyond repair!

Finding both these conclusions hard to accept I persuaded, with the help of the Executive Committee, that faithful friend of the IAU, Patrick Wayman, to chair a subcommittee on IAU Commission Structure: this was one limited aspect of the IAU which we thought should be examined in detail. As I expected, the sub-committee did not find the IAU to be perfect; they made a number of constructive criticisms - nothing very radical but nevertheless valuable. I hope you will read their report; a summary was published in the IAU Bulletin No. 53. To my mind one of the most important sections of that report is where they draw our attention to the importance of the part played by the Presidents and Vice-Presidents of our Commissions and suggest how the procedure for electing them might be improved.

Looking to the future let me draw your attention to one or two points; firstly I invite you to note the presence at this General Assembly of a large contingent of astronomers from the People's Republic of China - the Executive Committee has done everything in its power to encourage their attendance and we are delighted to see them here. We look forward to the part which I am sure they will play in the life of the Union.

There are, I should add, a number of countries in which astronomy is practised but which do not, as yet, adhere to this Union. The Executive, largely thanks to the personal efforts of the General Secretary, is exploring whether or not the IAU can play any useful part in the development of astronomy in those countries.

May I also invite you to note from the Draft Budget for 1986-1988 put forward by the Executive, that we propose to increase substantially the fraction of our budget which is spent on the support of international symposia and colloquia; this proposal is put forward in the simple conviction that these meetings represent one of the most worthwhile activities of this Union.

Finally let me say that my own experience of the last three years suggests that, although the IAU is not perfect, nevertheless it is meeting its present obligations very well and, as far as I can see, it is in good shape to meet the future.

## 1. Formal Opening

The President welcomed the members of the Union, Invited Participants and Registered Guests. He emphasized the value of individual membership, and extended a special welcome to those of the members who have belonged to the Union for fifty years or more, especially those who were present at the XIXth General Assembly:

The representative of ICSU, Prof. Edith Müller read a message from ICSU:

"The President of ICSU has asked me to express his regrets that he is unable to be with you on the occasion of the XIXth General Assembly of the International Astronomical Union. He has asked me to extend to you his best wishes for a successful Assembly.

As one of the founder organizations of ICSU's predecessor, the International Research Council, the International Astronomical Union has played and continues to play an important role in ICSU and in its development. This applies particularly at the present moment when your Secretary General, Dr. Richard West, is a member of the Executive Board of ICSU.

The development of science in the last forty years has been considerable. ICSU has made a number of changes in its organization, statutes and methods of work in an endeavour to adapt to such changes. Such modifications have been beneficial but it was recently decided to have a more thorough study of the organization of international science and ICSU's role therein, and a conference was organised recently which brought together about 50 people from within and outside the ICSU family. A wide range of suggestions were put forward and these are being reviewed by a small group which will suggest short and longer term follow-up actions to the Executive Board, which will then put its proposals to the ICSU General Assembly in September 1986.

One of the points that came out strongly in the conference discussions was the importance of ICSU's role in basic science and particularly in the preparation and organization of programmes of basic science studies, such as that proposed on Global Change, not being undertaken by other organisations.

Another point that came out strongly was the need for ICSU and the members of the ICSU family to increase their visibility. In this respect it is a pleasure to note the care with which arrangements for the Press have been made during this Assembly.

Mr. President, distinguished participants, you have a busy period in front of you and I would not wish to diminish the time available to discuss science. Let me close, therefore, in reiterating the best wishes and to say how pleased I am to see once again so many friends and colleagues."

## 3. Report of the Executive Committee 1982-84

The President invited discussion about the Report of the Executive Committee for the 3-year interval 1982-84, as an extract was presented in IAU Information Bulletin No. 54.

He mentioned that it had been given consideration by the official representatives of

Adhering Organizations, who, with the important reservation that the financial section of the report would come under scrutiny of the Finance Committee of the General Assembly, were prepared to recommend adoption of the report, subject to further discussion here.

There were no points raised from the audience, and the General Assembly unanimously approved the Report of the Executive Committee (1982-1984), subject to a relevant report by the Finance Committee (the full report is printed in this volume, see Chapter III).

## 4. Report of the General Secretary (January-November 1985)

## a) IAU Membership Nominations

The President asked the General Secretary to inform the General Assembly about proposals of individuals to IAU Membership.

The General Secretary indicated that he had received almost 900 proposals of individuals to IAU membership. A further 43 were received from Presidents and members of the Executive Committee.

#### b) Report by the General Secretary

First of all, I should like to thank most heartily the President and the Assistant General Secretary, as well as the other members of the Executive Committee for their very efficient support during the recent period of great activity. Moreover, I believe that a few of you realize how much work has been done during the past three years by the two secretaries, Mrs. B. Manning and Miss D. Lours, as well as by my secretary in Munich, Mrs. E. Völk, and by Mrs. D. Fraipont, secretary to the Assistant General Secretary in Liège. We are privileged to have been helped by them during our period of office and I should like to express my sincere thanks to them.

The main effort during the past ten months has been directed towards the organization of the XIXth IAU General Assembly here in Delhi. The work involved the arrangement of the scientific programme and all the practical details of travel and lodging. As you undoubtedly already noticed, our Indian colleagues have established a most impressive organisation around this meeting which is running as smoothly as anybody could expect. It is a particular pleasure to thank the members of the National and Local Organizing Committees and the Chairmen, Profs. M.G.K. Menon and A.P. Mitra. They have managed to gain access to Vigyan Bhavan for us. It is the Prime Minister's conference complex, and I am told that very few scientific organizations have ever been given this great privilege.

We are also thankful for the extensive financial support which has been given to this General Assembly and which has allowed the IAU and the Local Organisers to support no less than 250 scientists. Most of these are young and many come from countries where astronomy has not yet been fully developed. I am sure that they and their colleagues from other countries who come for the first time to an IAU General Assembly will find this a most useful and scientifically beneficial experience.

The programme in front of us is very full, but you should be able to keep track of what is going on through the daily issues of the newspaper "Mandakini" and by reading regularly the notice boards. I should also like to say that the organisers and the IAU Executive Committee have placed a special emphasis on the press relations at this meeting. There will be several press conferences and I ask you kindly to be available for interviews with scientific reporters.

Another important item during the past months has been the now completed computerization of the entire IAU member file. Telephone, telex, commission membership, etc., have been added and this will greatly facilitate interaction among IAU members in the future. It is expected that the updated lists, including the new members, who will be admitted at this General Assembly, will become available in early 1986. As a special service to Commission Presidents, the Secretariat will be able to produce address labels for commission members. This will facilitate the work of the Commission Presidents and hopefully increase the frequency with which they are in contact with their members through circular letters etc.

There have been many other activities, and you will hear about most of them during this General Assembly. I wish you a profitable meeting and look forward to have the opportunity to meet many of you in person during the coming days.

Kitamura as members. The General Assembly unanimously agreed to this composition of the Resolutions Committee.

## 9. Revisions of the Statutes and By-Laws

The change in By-Lay 17 such as mentioned in § 9 of the Agenda, is approved.

### 10. Resolutions submitted by Adhering Bodies

No resolutions were proposed to the XIXth General Assembly by Adhering Bodies.

## 11. Resolutions submitted by Commissions or by Associated Inter-Union Commissions

The President mentioned that six motions proposed by Commissions had been notified to Adhering Organizations for inclusion in the Agenda. However, the Executive Committee

proposed that some of these Resolutions be referred to the Resolutions Committee and be taken under Item 5 of the Agenda of the Second Session of the XIXth General Assembly.

The President then formally adjourned the meeting to Thursday, November 28, 1985 at 10:00 and closed the Session with a word of thanks to the participants.
