Naomi Cahn teaches family law, children and the law, and trusts and estates at George Washington University Law School, and writes in the areas of family law, including adoption and child welfare, feminist jurisprudence, and legal ethics. She is currently co-editing (with Joan Heifetz Hellinger) an anthology of adoption articles to be published by New York University Press. For the academic year 2002–2003, she is living in Kinshasa, Democratic Republic of the Congo.

**E. Wayne Carp** is Professor of History and Chair of the Department of History at Pacific Lutheran University. He is the author of *Family Matters: Secrecy and Disclosure in the History of Adoption* (Harvard University Press, 1998) and *Bastard Nation and the Politics of Reform* (forthcoming, University Press of Kansas, 2003), and editor of *Adoption in America: Historical Perspectives* (forthcoming, University of Michigan Press, 2002). He is currently writing a biography of Jean Paton, the "mother" of the adoption rights movement.

Catherine Connolly is Director of the Women's Studies Program and Associate Professor of Sociology at the University of Wyoming. She earned a Ph.D. and a J.D. from the State University of New York, Buffalo. Her research interests include examinations of inequality and the law, with emphases in the areas of gay and lesbian parents, domestic violence, and wage inequality. Her work on parenting and the law has been published in *Behavioral Sciences and the Law* and in *Studies in Law, Politics, and Society*. Her work on domestic violence has been published in the *Journal of Criminal Justice*, and that on wage inequality in *Research in the Sociology of Work*. She has projects currently underway in all of these areas.

Claudia Fonseca (Doctorat d'Etat, Univ. de Nanterre) is a full professor in the Department of Anthropology at the Universidade Federal do Rio Grande do Sul. Her areas of interest include gender relations, social organization, and adoption, as well as human rights and legal anthropology. Her articles have appeared in Les Temps Modernes, Les Annales ESC, Ethnologie Française, Droit et Cultures, Anthropologie et Sociétés, Anthropos, Anuário Antropológico, Horizontes Antropológicos, and Revista Brasileira de Ciências Sociais. Recently she has published two books: Caminhos da adoção (São Paulo: Editora Contexto, 1995) and Família, Fofoca e Honra (Porto Alegre: Editora da UFRGS, 2000).

Alice Hearst is an Associate Professor in the Government Department at Smith College in Northampton, Massachusetts. Her research interests lie generally in the relationship between the family, the state, and issues of citizenship. She is currently working on a manuscript examining group rights in the context of transnational, transracial, and transcultural adoption.

Kay Johnson is Professor of Asian Studies and Political Science at Hampshire College in Amherst, Massachusetts, where she has been teaching and conducting research concerning contemporary China for 20 years. Her early studies concerned women and the family in rural China, focusing on the impact of various policies on women's lives and status. Since the early 1990s she has been studying population policies and their impact on women and children. She has conducted research on infant abandonment and domestic adoption in China and has facilitated research by her Chinese collaborators on U.S. adoptive families of Chinese children. She is currently investigating the lives of "hidden" unregistered children in China.

**Katherine O'Donovan** is Professor of Law at the University of London. She has studied law in Ireland, France, and the United States and has taught in such varied jurisdictions as Ethiopia, Malaysia, and Hong Kong. Her research interests are in sociolegal and feminist perspectives on family law and medical law. Books published include Sexual Divisions in Law (1985), Equality and Sex Discrimination Law (1988), Family Law Matters (1995), and Human Rights and Legal History (2000).

Kimberly Richman is a doctoral candidate in the Department of Criminology, Law and Society at the University of California, Irvine. Her interests include gender, sexuality, and law; the construction and social control of morality; family law; and court processes. She is the author of two articles on the topic of domestic violence, appearing in Sociological Inquiry and Studies in Law, Politics, and Society. She also co-authored a chapter on anti-gay violence with Valerie Jenness in the Handbook of Lesbian and Gay Studies. Her current research analyzes judicial narratives and meaning-making in child custody cases involving gay and lesbian parents from a constitutive perspective. Her work in this area has been supported and recognized by the National Science Foundation, the American Sociological Association, the Society for the Study of Social Problems, and the American Society of Criminology.

Beacon, 2001). Susan M. Sterett is Associate Professor of Political Science at the University of Denver. She is the author of Creating Constitutionalism? (University of Michigan Press, 1997) and Serving the State: Constitutionalism and Social Spending in the States, 1850–1937 (Cornell University Press, forthcoming) as well as a number of articles in journals, including Law and Social Inquiry, Comparative Political Studies, and Studies in American Political Development.
