

ABOUT THE AUTHORS

W. A. BOGART is Professor of Law, University of Windsor. He is at work on a book on the impact of litigation on the social and political life of Canada.

JEFF T. CASEY is Assistant Professor in the Harriman School for Management and Policy at the State University of New York at Stony Brook and is currently Visiting Assistant Professor at the Graduate School of Business, University of Chicago. His research concerns judgment and decisionmaking under risk and ambiguity, psychological models of economic behavior, and taxpayer compliance.

ROBERT D. COOTER is Professor of Law at the University of California, Berkeley. He is coauthor of *Law and Economics* (with Thomas Ulen) and is co-editor of the *International Review of Law and Economics*. His research interests include the regulation of financial institutions, the economics of tort and property law, and the interface between economics and jurisprudence.

ROGER COTTERRELL is Professor of Legal Theory in the University of London, at Queen Mary and Westfield College. He is author of *The Sociology of Law: An Introduction* and articles and essays on legal and social theory. His critical text on legal philosophy in political context, *The Politics of Jurisprudence*, will be published in the United States by the University of Pennsylvania Press in 1992.

MALCOLM M. FEELEY received his Ph.D. in political science from the University of Minnesota and has taught at New York University, Yale, and the University of Wisconsin. Since 1984 he has been Professor of Law at the University of California at Berkeley, where he is involved in the Jurisprudence and Social Policy Program and directs the Center for the Study of Law and Society. "The Vanishing Female" is one of several studies of the emergence of modern criminal justice institutions and practices that he has undertaken in recent years.

HAROLD G. GRASMICK is Professor of Sociology and Co-Director of the Center for the Study of Crime, Deviance and Social Control at the University of Oklahoma. Much of his research attempts to integrate deterrence theory with theory that emphasize extralegal mechanisms of social control. Recent publications have also explored the link between religion and preference for punitive justice policies.

KARYL A. KINSEY is a Research Fellow at the American Bar Foundation. Her previous research has focused primarily on tax administration and tax compliance. Her current research examines the cognitive processes by which citizens evaluate the fairness of public policies and their contacts with tax authorities.

HERBERT M. KRITZER is Professor of Political Science at the University of Wisconsin–Madison. He is the author of *The Justice Broker* (Oxford University Press, 1990) and *Let's Make a Deal* (University of Wisconsin Press, 1991). In addition to the propensity to sue, his current research interests include alternative forms of representation and advocacy and the impact of procedural rules (e.g., Rule 11) on the civil justice process.

DEBORAH L. LITTLE received her J.D. from Georgetown University and is currently a Ph.D. student in sociology at the University of California at Berkeley. Her research interests include gender, feminist theory, criminology, and the state, with a special emphasis on poor women and the welfare state.

MARIJKE MALSCH is a staff member of the National Patients Association in Utrecht, The Netherlands. Recently, she published the book *Advocaten voorspellen de uitkomst van hun zaken* (Lawyers' Predictions of Judicial Decisions: A Study on Calibration of Experts).
