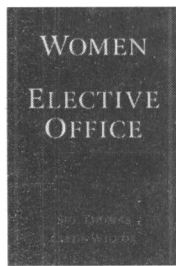
The Cold War focuses on the tumultuous relationship between the U.S. and the former Soviet Union, examining the radically divergent paths they took after 1917. Powaski looks at the Marshall Plan, the communist coup in Czechoslovakia, the Berlin blockade, the formation of NATO, and the first Soviet nuclear test. Throughout, Powaski stresses the events of special interest to America, including the Vietnam War, the Arms Race, and the domestic effects of the superpower competition. He discusses the onset of the Cold War under Truman and Stalin, its globalization under Eisenhower and Khrushchev, and the latter-day episodes of confrontation and détente. Powaski gives credit to Reagan and especially to Bush in facilitating the Soviet collapse, but also notes that internal economic failure, not outside pressure, proved decisive in the Communist failure. He also offers a clear assessment of the lasting distortions the struggle wrought upon American institutions, raising the important question of whether anyone really won the war. With clarity, fairness, and insight, Powaski offers the most comprehensive survey to date of the Cold War.
