No government paid more attention to the early activities of the Wright Brothers than the British, but British negotiations with the Wrights present a record of lost opportunities, mingled with ineptness and duplicity. The fascinating story includes a bungling British spy, an attempt by the cofounder of the Rolls-Royce motor car company to steal the Wrights' technical secrets, the breaking off of negotiations in 1909 by Britain's Secretary of State for War (who was banking on receiving the purloined secrets), and high-level infighting by such eminent figures as Winston Churchill, Lloyd George, Admiral Fisher, General Haig, and Lord Northcliffe. \$35.00

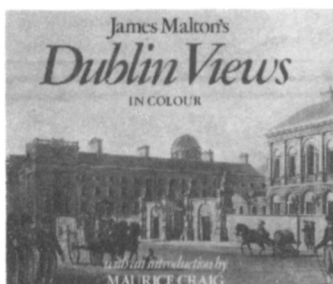

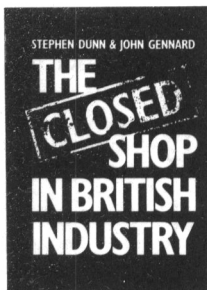

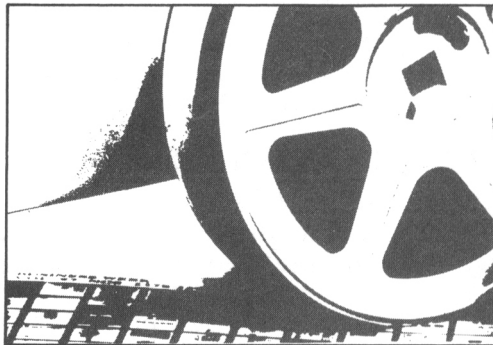
