Pierre Aubenque is professor emeritus at the University of Paris IV, Sorbonne, doctor *honoris causa* from the universities of Leipzig and Santiago de Compostela and Laval University (Quebec), and permanent guest lecturer at the University of Leipzig. He was guest lecturer at Bayreuth University (1998) and programme director at the Collège International de Philosophie in Paris. Since 2004 he has been tenured professor of the Yvonne Arnould chair at Tulane University, New Orleans. His chief publications are: *Théorie critique et modernité négro-africaine* (Paris, 1993); *La philosophie négro-africaine* (Paris, 1995); *L'art négro-africain* (Paris, 1997); and *La palabre, une juridiction de la parole* (Paris, 1997). *Address*: c/o Diogenes.
