

ous spring meeting—at least as ad hoc participants. Their tenure is supposed to correspond to that of the President who appoints them, but they in fact join the Council two (or more) meetings later. Surely it would be to the Council's benefit to remedy this peculiarity."

Marshall moved that the Council go on record as approving all three recommendations of the Program Committee Chairpersons. The motion was approved by a voice vote.

Gabriel A. Almond Award

The Council received a memorandum from David Apter, et. al. (a copy of which is attached to the record copy of these minutes) requesting the establishment of a Gabriel A. Almond Award to be granted at the award ceremony of the American Political Science Association meeting for the best dissertation completed and accepted during the previous year in the field of Comparative Politics. Greenstein moved that the Council approve the request. The motion was approved by a voice vote.

Dates for Next Council Meeting

It was agreed that the Administrative Committee would meet at the Palmer House in Chicago the morning of Tuesday, August 31; that the Council would meet starting at 1:00 p.m. on Tuesday, August 31, and continue through Wednesday, September 1.

APSR Articles

Marshall moved that authors of *APSR* articles be permitted to make only minor changes in proof except at their own expense. The motion was approved by a voice vote.

Lipset proposed that the Council express its view (sense of the Council) that a letter go out when a manuscript is accepted that there is a

commitment to publish, but there is a possibility that the format of the publication may change and it may not be the *APSR* as currently constituted. The Lipset proposal was adopted with the understanding that it would not be binding upon the Editor-Elect, Charles Jones, who was absent when the discussion took place.
