Authors submit manuscripts to the editor for consideration as ARTICLES or REPORTS in English, Spanish, or Portuguese. The normal, expected length of an ARTICLE will be 10–15,000 words, including bibliographies and tables. REPORTS should be under 10,000 words. Tables and illustrations should be limited to those that are appropriate and necessary. Authors are required to submit manuscripts electronically through Editorial Manager® (<http://www.editorialmanager.com/laq>).
