## CONTRIBUTORS

SPENCER R. CREW is head of the Collection of Advertising History in the Archives Center, National Museum of American History, Smithsonian Institution. He received his Ph.D. from Rutgers University in 1979 and has published in the field of Afro-American urban history. He is completing work on a major exhibition on Afro-American migration from the South to the North, entitled "Field to Factory: Afro-American Migration, 1915–1940."

JOHN A. FLECKNER is head of the Archives Center, National Museum of American History, Smithsonian Institution. He received his M.A. in American history from the University of Wisconsin, Madison. Active in the Society of American Archivists, he chairs its Committee on Goals and Priorities.

MICHAEL R. GODLEY is lecturer in history at Monash University in Melbourne, Australia. An American, he received his Ph.D. from Brown University. His publications include *The Mandarin-Capitalists from Nanyang* (1981) and numerous articles on Sino-Southeast Asian relations and Chinese history and politics.

ALBRO MARTIN is Oglesby Professor of the American Heritage, emeritus, at Bradley University. He is the author of a biography of James J. Hill and of other books and articles on the relationship of American business and businessmen to American society. He was a member of the faculty of the Harvard Business School from 1976 to 1982, when he served as editor of the *Business History Review*.

PAUL J. MIRANTI, JR., is assistant professor of accounting at the School of Business at Rutgers University. He received his Ph.D. in 1985 from the Johns Hopkins University. JULIET E. K. WALKER is associate professor of history at the University of Illinois, Urbana-Champaign. She received her B.A. from Roosevelt University, and her M.A. and Ph.D. in American history from the University of Chicago. A specialist in Afro-American history, she is the author of *Free Frank: A Black Pioneer on the Antebellum Frontier* (1983). Her research interests include antebellum blacks and the law, property ownership, land settlement

patterns and business participation, and black women historians and historiography. She is currently completing a monograph on “Captive Capitalists: Antebellum Black Entrepreneurship and Business Enterprise.”
