Principles of Public International Law Relating to International Antitrust Law

(in German)

Worldwide activities of multinational corporations and differing national approaches to competition policy have presented and will continue to present difficult problems to the application of antitrust laws. In most legal systems, the principles of public international law relating to international antitrust law guide the interpretation of the municipal rules on personal jurisdiction and on jurisdiction over the subject matter.

A realistic assessment of state practice leads the author to the conclusion that the traditional principle of territoriality and its more recent derivatives have become inadequate in an age of economic interdependence. The effects of restrictive trade practices provide a sufficient basis for state jurisdiction. The »effects« principle is, however, subject to some inherent limitations along the lines of § 18 b Restatement Foreign Relations Law. Furthermore, the exercise of jurisdiction is considerably restrained by the principle of nonintervention, which postulates a weighing of national interests, and by the minimum standard of international law in favour of foreign natural and legal persons.

The elaboration of such principles is based on some 200 decisions in the field of international antitrust law. Without neglecting the famous decisions of the past such as American Banana, Alcoa and Swiss Watch, special attention is paid to the cases of the 1970s: Ciba Geigy, Occidental Petroleum, Interamerican Refining in the United States; Line Pipes, Far East Freight Conferences in the Federal Republic of Germany; Dye-stuff, Continental Can in the Common Market.

STUDIES IN TRANSNATIONAL LEGAL POLICY

No. 1 *Long-Term International Monetary Reform: A Proposal for an Improved Adjustment Process*

Points to a structural change in the consultation and coordination procedures of the international monetary system to permit a system of relatively fixed exchange rates to function effectively. The Panel concludes that reliance on voluntary cooperation and on consultation on national economic policies is no longer satisfactory, and proposes new powers for the International Monetary Fund.
