THE SPANISH AMERICAN NOVEL

A Twentieth-Century Survey

John S. Brushwood

In this book, John Brushwood analyzes the twentieth-century Spanish American novel as an artistic expression of social reality. In relating the generic history of the novel to extraliterary events in Spanish America, he shows how twentieth-century fiction sets forth the essence of such phenomena as the first Peron regime, the Mexican Revolution, the Che Guevara legend, indigenismo, and the strong-man political type. In essence, he views the novel as art rather than as document, but not as art alienated from society. The discussion is organized chronologically, opening with the turn of the century and focusing on novels from 1900 to 1915 that exemplify various aspects of the nineteenth-century literary inheritance. Brushwood then highlights the avant-garde fiction (influenced by Proust and Joyce) of the 1920's as a precursory movement to the "new" Latin American novel, a phenomenon that came into its own during the 1940's. He then examines the "boom" in Spanish American fiction, the period of extensive international recognition of certain works, which he dated from 1962 to 1963.

A MEXICAN FAMILY EMPIRE

The Latifundio of the Sanchez Navarros, 1765–1867

Charles H. Harris III

Perhaps no other institution has had a more significant impact on Latin American history than the large landed estate—the hacienda. In Mexico, the latifundio, an estate usually composed of two or more haciendas, dominated the social and economic structure of the country for four hundred years. *A Mexican Family Empire* is a careful examination of the largest latifundio ever to have existed, not only in Mexico but also in all of Latin America—the latifundio of the Sanchez Navarros. This book is based on the Sanchez Navarro papers—75,000 pages of personal letters, business correspondence, hacienda reports and inventories, wills, land titles, and court records spanning the period from 1658 to 1895. Harris's thorough research of these documents has resulted in the first complete social, economic, and political history of a great estate. The geographical and chronological boundaries of his study permit analysis of both continuity and change in Mexico's evolving socioeconomic structure during one of the most decisive periods in her history—the era of transition from colony to nation.

MARKETS IN OAXACA

Edited by Scott Cook and Martin Diskin

Markets in Oaxaca is a study of the regional peasant marketing system in the Valley of Oaxaca, Mexico. It relates the marketing system to other aspects of the regional economy, to neighbouring regions, and to the Mexican national economy. Combining ethnographic, theoretical, and regional analyses, it suggests new directions in the fields of peasant and development studies. Contributors to the volume describe the operation and nature of several marketplaces in the region, analyze village-based artisan production and various specialized economic roles (particularly the role of traders), and describe the operation of several total regional marketing systems. The editors then consider their findings against the background of political, economic, and social structures from the pre-Conquest period to the present. In their conclusion, they view the regional peasant economy as one molded by the dependence on the urban-industrial sector, although they found structural integrity and internal dynamism in the system itself.

THE IDEAL OF THE PRACTICAL

Colombia's Struggle to Form a Technical Elite

Frank Safford

The methods infusing technical knowledge and technical orientations into an aristocratic Latin American society have been dealt with only occasionally by sociologists, labour economists, and educationists concerned with contemporary problems. *The Ideal of the Practical* is the first in-depth historical study of the problems involved. Frank Safford describes the efforts of Colombia's nineteenth-century political elites to introduce technical knowledge, skills, and value orientations into its aristocratic society, which was founded on a static agrarian economy. *The Ideal of the Practical* opens with a description of the economic and social context of nineteenth-century Colombia, then discusses some early experiments with manual industrial training between 1820 and 1850. It explains the development of engineering in Colombia after 1850. Chapters deal with the careers of upper-class youths sent abroad for scientific and technical training, the growth of indigenous engineering education, and the crystallisation of a Colombian engineering profession. While the book primarily explores the nineteenth century, it also touches on eighteenth-century Spanish Bourbon antecedents and provides an epilogue on the twentieth-century evolution of technical elites in Colombia.

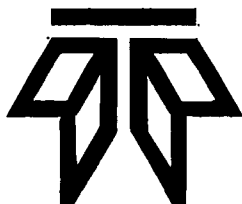
The Politics of Trade Rivalry

Stanley E. Hilton

Based on extensive research in four countries and on unprecedented access to various Brazilian archives, *Brazil and the Great Powers* offers a new interpretation of Brazilian economic policy during the 1930s. It serves as a revisionist view of the role of the military in the formulation of economic policy during that period. Furthermore, the book challenges prevailing notions of the effectiveness of the Good Neighbour Policy. The author focuses on Brazil's response to the intensive struggle between the great powers—Germany, Great Britain, and the United States—for overseas markets and raw materials during the turbulent years of the 1930s. In an evaluation of the policies followed by the Vargas government, he discusses individuals and groups involved in decision making on Brazilian trade policy and analyzes their motives. He pays special attention to the alliance of commerce and the military that led to a skillful, opportunistic policy among strong powers who made conflicting demands on Brazilian leaders.

BEYOND THE CODICES

The Nahua View of Colonial Mexico

*Edited and translated by
Arthur J. O. Anderson, Frances Berdan,
and James Lockhart*

Most studies of colonial Mexico have depended mainly on Spanish language sources, even though many writings survive that were composed in Nahuatl, the language of the Aztecs. Here is a collection of thirty-five Nahuatl documents presented both in transcription and English translation, together with a substantial introductory essay. It presents for the first time in published form the Indian view of colonial Mexico, in contrast to the view well known from Spanish records.

Included in the collection are a representative sample of wills and related documents, land documentation, municipal documentation, and petitions, correspondence, and other formal statements. For historians and anthropologists the selections afford an intimate look inside the Indian world as it was adjusting to the Conquest. For linguists, these are fresh texts from a variety of times and places, providing a wealth of material for diachronic and dialectical analysis.

THE MEXICAN PROFIT-SHARING DECISION

Politics in an Authoritarian Regime

Susan Kaufman Purcell

This is the first detailed study of the decision-making process on the national level in Mexico. It examines President López Mateo's decision to implement the provisions for profit-sharing of the 1917 Constitution, a decision that involved the most important groups in the country, organized business and labor, and their relationship with the executive branch of the government. Relying heavily on unpublished sources such as letters, minutes of meetings, and interviews, the author illuminates the role of the dominant political party (the PRI), the mechanisms used by the regime to resolve conflict, and the symbolic aspects of Mexican politics.

An important part of the work is its description of how the centralization of political power, the limited autonomy of interest groups, and the dominance of an "official" political party produce a decision-making style specific to authoritarian regimes.

THE EMERGENCE OF SPANISH AMERICA

Vicente Rocafuerte and Spanish Americanism, 1808-1832

Mr. Rodríguez O. argues persuasively that Spanish American independence did not bring about a sharp break between colonial and national periods. On the contrary, the conflicts which divided Hispanic society went on as before; all that Spanish America achieved was separation from Spain. This study of the dissolution of the Spanish empire in America is focused on the public career of one man, Vincent Rocafuerte, perhaps the most representative member of a group of Spanish American liberals who worked for independence and for a new vision of Spanish American community. Rocafuerte participated in all phases of this movement (referred to by the author as *Spanish Americanism*) from its inception in the Spanish Cortes (1810-1814) to its decline in the 1830's.

PROLOGUE TO PERÓN

Argentina in Depression and War, 1930-1943

Since 1943 the personality of General Juan Perón has towered over the Argentine Republic. Yet until 1930 Argentina was widely regarded as the best example of democracy and prosperity on a politically turbulent, economically underdeveloped continent. The present collection of articles by American and Argentine scholars examines the thirteen critical years that separated the "old" Argentina from the "new" and made possible the rise of one of the most powerful dictators in South America.

In a little over a decade wracked by depression and war, political democracy in Argentina collapsed; the traditional economic relationship with Great Britain deteriorated; a generalized disillusionment on the part of intellectuals led to a fascination with authoritarian ideologies; a new "nationalistic" consciousness became increasingly evident in popular entertainment; and social and demographic changes produced a constituency for a messianic populism.

THE MYTH OF MARGINALITY
Urban Poverty and Politics in Rio de Janeiro

Janice E. Perlman

The "myth of marginality" analyzed here is a set of stereotypes about the urban poor of the world, and particularly the poor migrant settlers of jerrybuilt communities in Latin America. Residents of the *favelas*, as these places are called in Brazil, are said to be politically alienated, parasites on the economy, inclined toward crime, and altogether a blight upon the landscape. Official policy in Brazil has called for destruction of the *favelas* and removal of the residents to government-built public housing. Establishment social scientists in the U.S. and Latin America have in the main supported such policies.

Dr. Perlman, who lived in and closely studied several *favelas* over a period of six years, contends the prevailing wisdom is false. She provides persuasive evidence that: socially, residents of *favelas* are well organized and cohesive; culturally, they share middle-class norms and values; economically, they are productive; politically, they are neither apathetic nor radical.

Many new insights into third-world urban poverty are presented in this book; it will have a lasting impact on the course of future research, and perhaps of policy as well.

Journal of Latin American Studies is published twice a year under the academic sponsorship of the Centres or Institutes of Latin American Studies at the Universities of Cambridge, Glasgow, Liverpool, London and Oxford.

The scope of the journal is the study of Latin America from the standpoint of the social sciences, including anthropology, archaeology, economics, geography, history, international relations, politics, sociology, etc., though it is not concerned with linguistic or literary studies.

Editorial policy avoids commitment to any political viewpoint or ideology, but welcomes free discussion of such issues in the Latin American context, on the understanding that all responsibility for opinions expressed rests exclusively with the author concerned and not with either the journal or its editors.

Contributions are invited from all parts of the world. Articles should generally not be more than 8,000 words long, and two copies, typed with double-spacing, should be submitted. Diagrams and maps may be included by arrangement with the editors. The journal is published in English, but articles written in other languages may be considered, and arrangements made as required for translation into English. Contributors should keep one copy of the typescript for use in correcting proofs.

All contributions and editorial correspondence should be addressed to *Journal of Latin American Studies*, Institute of Latin American Studies, 31 Tavistock Square, London, WC1H 9HA.

Each contributor will receive, free of charge, 25 offprints of their article and a copy of the issue of the journal in which it appears.
