Plato's *Parmenides*

The Conversion of the Soul

Mitchell H. Miller, Jr.

The *Parmenides* is arguably *the* pivotal text for understanding the Platonic corpus as a whole; it is also, in itself, the most perplexing of all the dialogues. To understand the significance of the first part, Plato's apparently devastating objections to his own theory of forms, one must interpret it in connection with the second part, the hypotheses on "the one." Yet the subject, coherence, and point of the hypotheses are notoriously obscure. Mitchell Miller offers a new reading that takes as its key the closely constructed dramatic context and mimetic irony of the dialogue. Read with these in view, the hypotheses emerge as a systematic response to the objections, charting a radical and distinctively conceptual rearticulation of the theory of forms. The dialogue as a whole, in turn, functions as the means for a "conversion" of the soul toward eidetic being. \$30.00

Language and Desire in Seneca's *Phaedra**Charles Segal*

This close reading of Seneca's most influential tragedy explores the question of how poetic language produces the impression of an individual self, a full personality with a conscious and unconscious emotional life. Ovid and the Traditions of Augustan Poetry
by P. E. KNOX

Having established his reputation as an elegist, Ovid turned to the composition of hexameter narrative. Although the *Metamorphoses* has often been treated as an appendix to the history of Augustan poetry, the principal lines of stylistic and thematic development continue in Ovid's work. Drawing upon the structure and content of Vergil's Sixth Eclogue, the *Metamorphoses* is an intricate and allusive poem that combines elements from the entire range of Roman verse composed in the Alexandrian manner. Professor Knox focuses in particular upon the contributions of elegy and epyllion, examining the manner in which Ovid exploits the diction of these genres in order to distinguish his poem from traditional epic verse. The study concludes with an investigation of the aetiological stories of the final book and the sustained evocation of Callimachus' *Aetia* at its close.

Jews and Godfearers at Aphrodisias
by J. REYNOLDS and R. TANNENBAUM

This book presents a recently-discovered inscription from Aphrodisias in western Turkey, probably of the third century A.D., which throws unusual light on the history of the Jewish diaspora, on the background to early Christianity, and on the society of a Greco-Roman city below the level of its elite, who normally dominate the evidence. The inscription records a charitable donation to a synagogue community by Jews (including a few proselytes) and a category of men described as *theosebeis*, whom the authors interpret as gentiles with a serious interest in Judaism, like the 'God-fearers' of the Acts of the Apostles. These *theosebeis* range in status from city-councillors to fullers, and they reveal what kind of men were attracted by monotheism and its moral code; these men might also provide converts to Christianity. The text also reveals something of the professed ideals and activities of the donors: psalm-singing and law are prominent; the former sheds light on the history of Christian liturgy. Aphrodisias was not previously known to have had a Jewish community.

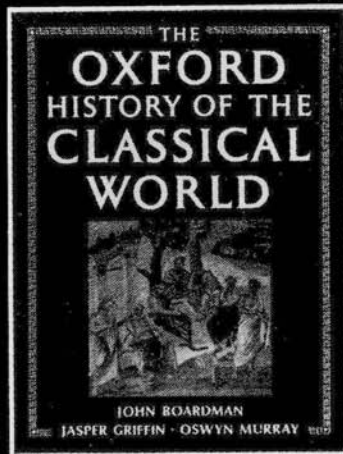

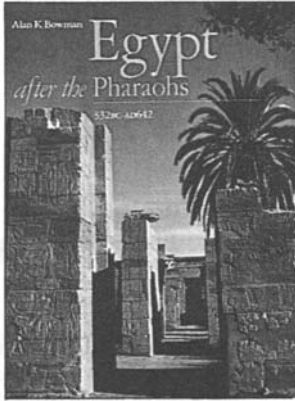

NOTES TO CONTRIBUTORS

1. One copy of an article will suffice. It will usually be returned if the contributor so requests on submitting it, but as the editors may wish to annotate it and furthermore cannot take responsibility for any loss, contributors should retain another copy.

2. Articles should be typed in double spacing on A4 paper and on one side of the paper only. Footnotes should be numbered consecutively and typed on separate sheets. Greek quotations need not be typed, but every letter must be clear and legible; especial care should be taken over accents and breathings.

3. Quotations in English, Latin, French, etc., should be put in single inverted commas, e.g.

... the phrase 'dux femina facti' has...

A quotation within a quoted passage has double inverted commas. Single words or self-contained phrases (such as *fait accompli*) may be underlined to indicate italics. Material inserted within a quotation is placed in square brackets:

'[The translator]... must ever be casting his eyes upwards from the copy to the original.'

4. References should normally be given in the footnotes, in the following form:

Authors' initials should be stated, at least at their first mention. Abbreviations should not be assigned to books unless they are generally familiar (e.g. *OCD*² omitting full points).

The Classical Association

The main aims of the Classical Association are to promote and sustain interest in classical studies, to maintain their rightful position in universities and schools, and to give scholars and teachers opportunities of meeting and discussing their problems. It organizes an annual conference, lasting four or five days, in a university centre, and sponsors twenty-nine branches, most of which hold Greek and Latin Reading Competitions for Schools. Its activities are fully reported in its annual *Proceedings*, issued free to all members.

The present membership of the Association is approximately 4,400. Membership is open both to individuals and to institutions at an annual subscription of £3.00 (life composition for individual members, £63.00). Members may obtain the *Classical Review* and *Classical Quarterly* at reduced prices (*Review*, £13.00; *Quarterly*, £14.00; combined subscription, £24.00). *Greece & Rome* may also be obtained through the Association for an annual subscription of £11.00. Application for membership and subscriptions for the journals (which should normally be received by 31 January in each year) should be addressed to the Hon. Treasurer, R.
