He is currently working on a book about the history of intellectuals in Latin America.

LESLIE ELLIOTT ARMIJO, Visiting Scholar at Portland State University, Oregon, writes on democratization, economic reform, and the international political economy. SARAH C. CHAMBERS is Associate Professor of History at the University of Minnesota. She published *From Subjects to Citizens: Honor, Gender and Politics in Arequipa, Peru, 1780–1854* (1999) and co-edited, with Sueann Caulfield and Lara Putnam, *Honor, Status, and Law in Modern Latin America* (2005). She is currently writing a book on family and politics in Chile during the late colonial and early national periods and co-editing a document reader on Latin American independence.

ALBERT ESTEVE is a Research Fellow at the Centre d'Estudis Demogràfics at the Universitat Autònoma de Barcelona. He has held research appointments at the Minnesota Population Center and the Institut National d'Études Démographiques, Paris. AGUSTINA GIRAUDY is a doctoral candidate in Political Science at the University of North Carolina at Chapel Hill. Her research interests include federalism, subnational politics, clientelism, and formal/informal institutions, with special focus on Argentina and Mexico.

JOSEPH L. KLESNER is professor and chair in the Department of Political Science at Kenyon College. He has written extensively about Mexican politics, especially electoral politics and public opinion. His articles have appeared in *Mexican Studies/Estudios Mexicanos*, *Latin American Politics and Society*, *Electoral Studies*, and other journals, as well as in edited volumes. In 2005–2006, he was a Fulbright visiting scholar at University College Dublin.

PABLO LACOSTE is a professor at the Universidad de Talca (Chile). He obtained his doctorate in History at the Universidad de Buenos Aires and a doctorate in American Studies at the Universidad de Santiago de Chile. His most recent works focus on the history of the wine industry, and have been published in *Hispanic American Historical Review*, *Colonial Latin American Historical Review*, *The Americas*, *Revista de Indias*, *Universum* and *Historia* among other journals, as well as in the book, *El vino del inmigrante*, which concentrates on argentine viticulture from 1880 to 1980. He directs the project “La vid y el vino en Cuyo y el Valle Central de Chile” (1700–1850), funded by the Fondo Nacional de Ciencia y Técnica de Chile (FONDECYT), which provided the context for the study published in this issue of LARR.

ROBERT McCAA is professor of Latin American History at the University of Minnesota, specializing in the population history of Mexico. His interest in assortative mating dates to the late 1970s with articles on *calidad* and *clase* in colonial Mexico followed by later studies on twentieth century Australia, New York City, and the USA. Currently he is assisting the IPUMS project to preserve the world’s census microdata and to make them available free of charge to researchers via the internet site <https://www.ipums.org/international>.

CARMELO MESA-LAGO is Distinguished Service Professor Emeritus of Economics and Latin American Studies at the University of Pittsburgh, former Professor and Research Scholar on International Relations, at Florida International University, and Emilio Bacardi Professor on Cuban Studies at the University of Miami, as well as visiting professor or researcher in Argentina, Germany, Mexico, Spain, Uruguay, and United Kingdom, and a lecturer in 36 countries. He is the author of 70 books and about 240 articles/chapters published in 8 languages in 33 countries, on social security, the Cuban economy, and comparative economic systems. His most recent books are *Market, Socialist and Mixed Economies: Comparative Policy and Performance* (Johns Hopkins University Press, 2000), *Las Reformas de Pensiones en América Latina y los Principios de la Seguridad Social* (ECLAC, 2004), *Cuba’s Aborted Reform: Socioeconomic Effects, International Comparisons and Transition Policies* (with J. Pérez-López, University Press of Florida, 2005) and *Las Reformas de Salud en América Latina y los Principios de la Seguridad*

Social (ECLAC, 2006). He has worked on social security issues in all Latin American countries, as a regional advisor in ECLAC, a consultant with most international financial organizations, several U.N. branches, and national and foreign foundations, and is a member of editorial boards of the *International Social Security Review* and other five academic journals. He was President of LASA, is a member of the National Academy of Social Insurance and has received the Alexander von Humboldt Stiftung Senior Prize, two Senior Fulbrights, the Arthur Whitaker and Hoover Institution Prizes, the Annual Distinction of the Association for the Study of the Cuban Economy, and homage for his life work both on social security (OISS, CISS) and the Cuban economy (Institute of Cuban Studies, *Revista Encuentro*).

CARLOS MORENO-JAIMES completed his Ph.D. at the University of Texas at Austin in 2005. He is research professor at the Instituto Tecnológico y de Estudios Superiores de Occidente (ITESO), Mexico, where he is also Director of the Masters Program in Politics and Public Management. He was previously a visiting researcher at the Center for U.S.-Mexican Studies at the University of California in San Diego. His research interests include fiscal decentralization and local governance in Mexico.

DR. EDUARDO POSADA-CARBÓ is currently a Research Associate at the Latin American Centre in St. Antony's College. He was a Senior Lecturer at the University of London, and has been visiting professor at several universities in Europe and in the Americas, including a Tinker Visiting Professor of Latin American History at Chicago University, Visiting Fellow at the Kellogg Institute in Notre Dame University, and Cogut Visiting Professor of Latin American Studies at the Watson Institute in Brown University. He is the author and editor of several books, including *La nación soñada. Violencia, Liberalismo y Democracia en Colombia* (Bogotá: Norma, 2006), and *The Colombian Caribbean: A Regional History* (Oxford University Press, 1996). He is also the author of several articles published in journals, including the *Journal of Democracy*, *Hispanic American Historical Review*, *Journal of Latin American Studies*, *Boletín Bibliográfico y cultural*, *Revista de Occidente*, and *Caravelle*. Before embarking upon an academic career, he was Director of *Diario del Caribe* (1986–88), a daily published Barranquilla, Colombia. He writes a regular column for *El Tiempo*, the Colombian leading daily. His current research is a study of the politics of language in the Colombian armed conflict.

JUAN CARLOS RAMÍREZ-PIMIENTA is Assistant Professor of Spanish at San Diego State University-Imperial Valley. He has researched and published articles on border studies, corrido studies, cinema studies, and detective fictions. He is the co-editor, with Salvador Fernández, of *El Norte y su frontera en la narrativa policiaca mexicana* (2005) and the author of *Del Periquillo al pericazo: Ensayos de literatura y cultura mexicana* (2006).

BEATRIZ J. RIZK is the Director of the Educational Unit of the International Hispanic Theatre Festival of Miami and a Board Member of NALAC (National Association of Latino Arts and Culture). She is the author of more than 100 articles and chapters on Latina/o and Latin American theater.

Her books include *El Nuevo Teatro Latinoamericano: Una lectura histórica* (1987), *Enrique Buenaventura: La dramaturgia de la creación colectiva* (1991), *Posmodernismo y teatro en América Latina: Teorías y prácticas en el umbral del siglo XXI* (2001), and *Teatro y diáspora: Testimonios escénicos latinoamericanos* (2002). She also coauthored the book *Latin American Popular Theatre: The First Five Centuries* (1993). Her most recent book, co-edited with Yana Elsa Brugal, is *Rito y representación: Los sistemas mágico-religiosos en la cultura cubana contemporánea* (2003).

JOSHUA M. ROSENTHAL is an Assistant Professor of in the Department of History and Non-Western Cultures at Western Connecticut State University. He is a student of Contra-Mestre Caxias of *Grupo Capoeira Brasil*. He is presently working on *Siervos de Sal: The Poverty of Colombia's Republican State*.

ANTHONY PETER SPANAKOS is Assistant Professor of Political Science at Montclair State University and Adjunct Assistant Professor at New York University's master's program in political science.
