The China Quarterly is pleased to award the 2011 Gordon White Prize to **Yuhua Guo and Peng Chen** for their article entitled “Digital Divide and Social Cleavage: Case Studies of ICT Usage among Peasants in Contemporary China” (September 2011, No. 207).

The £500 prize is awarded annually for the most original article or research report published in **The China Quarterly** in the relevant year.
