### Family Farming and Population in a Japanese Village, 1717–1830

*Thomas C. Smith.* Historians have long been intrigued by Japan's static national population during the 18th and early 19th centuries, when the output of the economy was almost certainly growing. Was population held in check by high mortality or low fertility, or by some combination of the two? The author of this classic case study suggests an answer through analysis of certain heretofore unperceived rural marriage and child-bearing patterns uncovered in the population and land registers of the village of Nakahara. ## Society and Homicide in Thirteenth-Century England

*James Buchanan Given.* This study of the patterns of homicide in London, Bristol, and five English counties from 1202 to 1276 reveals that homicide was a very frequent social phenomenon in medieval England and, indeed, that violence was regarded as an acceptable, and often necessary, facet of life. Using quantitative and computer methods, the author analyzes homicide as a social relationship that can tell us much about medieval life and social organization that might otherwise remain unknown or mysterious. All contributions and editorial correspondence should be sent to the Editors, *Comparative Studies in Society and History*, Department of History, University of Michigan, Ann Arbor, Michigan 48109.

Two copies of each contribution, preferably accompanied by a stamped, addressed envelope, should be submitted. Both text and footnotes should be clearly typed with double spacing and wide margins; footnotes should appear on separate pages at the end of the article. Illustrations may be included by arrangement with the editors.

Contributors will receive 50 offprints. Any additional offprints must be ordered on receipt of the first proof.
