The editors continue to welcome articles by scholars from all parts of the world. Review essays provide a forum for authors to develop opinions on a topic through discussion of recent books. Proposals should be developed with the Editor.

Manuscripts should be typewritten, double-spaced, with footnotes, references, tables, and charts on separate pages, and should follow the current journal style.
