The Mentality of the Great Tidewater Planters on the Eve of Revolution

The great Tidewater planters of mid-eighteenth century Virginia were fathers of the American Revolution, but they were also, perhaps first and foremost, anxious tobacco farmers, harried by the risks of trans-Atlantic shipping and by their uneasy relations with English agents. George Washington, Thomas Jefferson, and their contemporaries inhabited a world dominated by questions of debt— who got credit and how. T. H. Breen’s examination of the tobacco culture links a demanding planting cycle and a complex commercial network with a radical political ideology that stressed honor and personal autonomy.

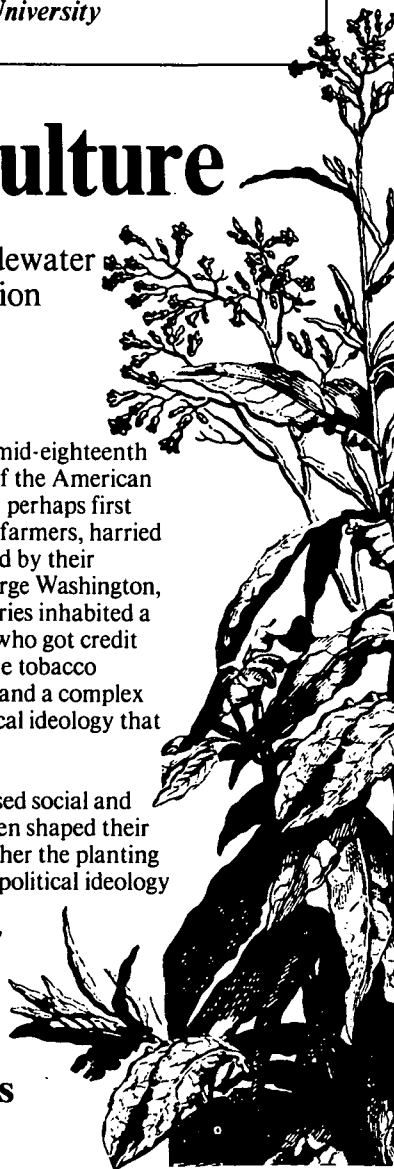

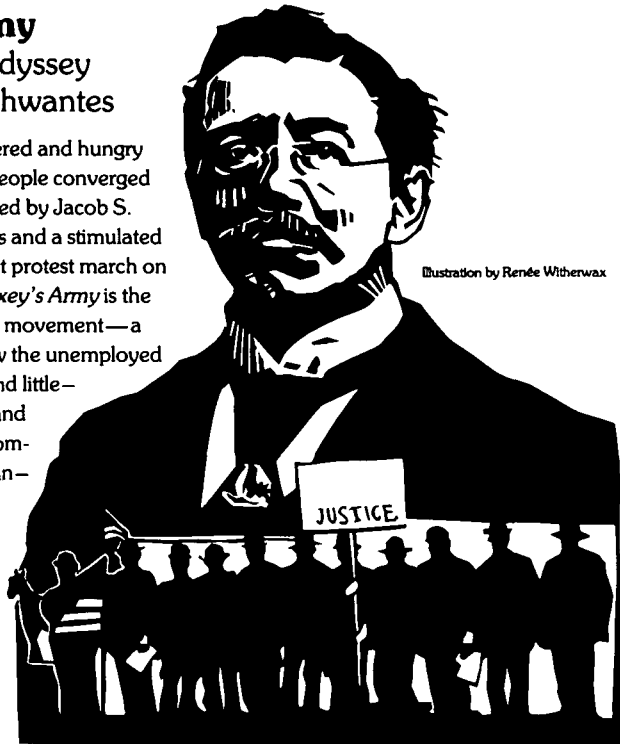

Om Prakash reveals the central role played by Bengal in the Dutch East India Company’s activities in India in the seventeenth and early eighteenth century and the resulting integration of India into the world economy. By the early 1700s, Bengal provided almost 40 percent of the value of Asian goods sent to Holland, and over half of all textiles exported from Asia by the Company. Long before this, the Company had carried goods from Bengal all over Asia. Drawing on little-used documents in the General State Archives in The Hague, the author discusses the place of the Company in Bengal from the beginnings of its trading operations there in the 1630s until about 1720. \$38.50
