URBAN PLANNERS EAST HARLEM/BRONX BUS TOUR . . . Saturday, September 2, 9:00 a.m. to 1:00 p.m.

Planners' New York Tours, a project of urban planners at Hunter College in New York City, has scheduled a special running of their East Harlem/Bronx tour on Saturday, September 2nd from 9:00 a.m. to 1:00 p.m. for participants at the Political Science Convention. For political scientists interested in urban social change and the government's proper role in guiding it, a visit to East Harlem and The Bronx is a special opportunity. Both are Model Cities areas and both contain vivid examples of virtually every federal, state, and city urban renewal approach since the depression. The tour links past urban renewal policies to their results and then projects into the future the needs of these areas and the possible responses emanating from President Carter's urban policy and the city's pending South Bronx Plan. In the Bronx the route will encompass areas President Carter visited plus much more, including Co-Op City, the largest housing project in the nation.

Planners' New York Tours also offers tours of Brooklyn and Central Manhattan, which along with the East Harlem/Bronx tour, are given weekly through the fall. 1978 Annual Business Meeting

1978 Rules for the Annual Business Meeting and Association Elections

On May 4, 1978, the Association's Council approved the following rules proposed by the Rules Committee to govern the conduct of the Association's 1978 Annual Business Meeting and Association Election.

1. Annual Business Meeting: Attendance and Participation

The right "to attend and to participate in the Annual Business Meeting of the Association" is constitutionally accorded "all members, upon payment of such registration fee as the Council may approve." (Art. III, sec. 7)

1.1 Attendance at the Annual Business Meeting shall be restricted to members of the Association who have paid the approved registration fee and to registered representatives of the media. Participation in the Annual Business Meeting shall be restricted to members of the

Association who have paid the approved registration fee.

1.2 Members upon registration shall be issued nontransferable badges readily distinguishable from badges issued nonmember registrants and representatives of the media.

1.3 The Registration Desk shall be open (in addition to the normal registration hours) at least during the first hour of the Annual Business Meeting or, if the Meeting is held in separate time periods, during the first hour of each such meeting.

1.4 A prospective candidate for elective office of the Association must become a dues-paying member upon filing for office.

1.5 One hundred members are necessary for a quorum (as required by Article VII, Section 1 of the Constitution).

2. Conduct of the Annual Business Meeting

2.1 The agenda of each Annual Business meeting will be: nomination and election of officers, Constitutional amendments, resolutions, and other business.
