
Notes on Contributors

Patrick Buckridge is Professor of Literary Studies at Griffith University, where he has taught literature for over thirty years. He has published widely on Australian and Queensland literature, and on the history of reading, and was co-editor, with Belinda McKay, of *By the book: a literary history of Queensland* (UQP 2007).

Mark Finnane is ARC Australian Professorial Fellow and a Professor of History at Griffith University, where he is a Chief Investigator in the ARC Centre of Excellence in Policing and Security (CEPS). He has published widely on the history of criminal justice, policing, punishment and criminal law in both Australia and Ireland. His most recent book, with Heather Douglas (University of Queensland), is *Indigenous crime and settler law: white sovereignty after Empire*, published in 2012 by Palgrave Macmillan.

Robert Mason is a Lecturer in History at the University of Southern Queensland. His research focuses on culturally and linguistically diverse communities in regional Australia. He is particularly interested in historical memory and heritage in contemporary communities, as well as the legacy of the Spanish and Portuguese empires in the Asia-Pacific region.

Belinda McKay teaches literature in the School of Humanities at Griffith University. With Patrick Buckridge, she co-edited *By the book: a literary history of Queensland*, which was published by University of Queensland Press in 2007.

Kelly McWilliam is a Senior Lecturer in Communication and Media Studies at the University of Southern Queensland. Since being awarded her PhD from the University of Queensland, she has researched and taught widely across film, media, and cultural studies, including publishing several books, securing over half a million dollars in grant funding (largely ARC funding) and winning multiple research and supervision awards.

Lyndon Megarrity is a Queensland historian. He is the co-author of *Made in Queensland: a new history* (UQP 2009).

Clive Moore is Professor of Pacific and Australian History and Head of the School of History, Philosophy, Religion and Classics at the University of Queensland. His major publications have been on Mackay, Australia's Pacific Island immigrants, the Pacific labour reserve, Australian federation, masculinity, gay Queensland, New Guinea and the Solomon Islands. He was the inaugural president of the Australian

Association for the Advancement of Pacific Studies (2006–10), and in 2005 received a Cross of Solomon Islands for his history work on Malaita Island. In 2011, he became a Fellow of the Australian Academy of the Humanities.

Paul Norton lectures and researches in the School of Government and International Relations at Griffith University, specialising in environmental politics and policy. His research interests include environmental politics and policy, relations between the labour movement and environmental movement, social movement theory, theories of radical democracy and wicked problems.

Peter Roennfeldt has published on the social history of Australian music in *The Oxford companion to Australian music* and *The Australian dictionary of biography*, and has curated recordings of heritage repertoire for the ‘Music Queensland’ project of the State Library of Queensland. In 2012, he published *Northern lyrebird*, a history of the Queensland Conservatorium Griffith University, where he is Professor of Music and a former director. As a keyboard performer and conductor, he has specialised in early music on period instruments, and has created performing editions of baroque works from original sources.

Cheryl Taylor taught literature at James Cook University in Townsville, Queensland for over thirty years. She is now an independent scholar who tutors and lectures casually at Griffith University in online and face-to-face literature courses. She is the founder of the ARC-funded AustLit subset, ‘Writing the north’, and has edited volumes and published refereed articles and reviews in the fields of Middle English and Medieval Latin literatures, as well as Queensland writing.







Instructions for Contributors

SUBMISSION INSTRUCTIONS

Queensland Review publishes articles of approximately 5000–6000 words. Please email submissions to *Queensland Review* to the Lead Editor, Dr Belinda McKay, at: b.mckay@griffith.edu.au

1. At least two separate files must be submitted. If there are figures, three or more separate files must be submitted.
 - i A Title Page document. The name of this file must be constructed as follows: [first 20 characters of the title]_[ddmmyear]_QR_Title.doc
 - ii An Article document. The name of this file must be constructed as follows: [first 20 characters of the title]_[ddmmyear]_QR_Article.doc
 - iii Any Figure documents should be supplied with the name of the file constructed as follows: [first 20 characters of the title]_[ddmmyear]_QR_Figure# (with # being the number of the figure)
2. The Title Page and Article documents should be saved as Microsoft Word documents, in Times New Roman 12 pt font, double-spaced with margins of at least 25 mm on both sides and in A4 page size.
3. The Title Page document should contain the full title of the article as well as the full names and affiliations of all authors followed by a full postal and email addresses for the corresponding author. A word count and suggested running head of no more than 50 characters including spaces should also be provided.
4. The Article document should include the complete article without any identifiable author details but including the title and an abstract not exceeding 200 words that provides a brief overview of the aims, method and major findings, without any citations. The abstract will not be published, but may be used for publicity purposes.
5. Tables should be created in Word and included at the end of the article after the references, with their approximate positions in the text indicated by the words, 'Insert Table X here'. Horizontal and vertical lines should be used sparingly.
6. Figures, graphs, illustrations and photographs (but not tables) should be prepared to the correct size and each one supplied as individual files, separate to the article. To ensure optimal quality, please follow the guidelines provided in the full instructions available at journals.cambridge.org/qre

A list of figure captions should follow the tables in the article document. Captions must include sources

and permissions for copyright material. It is the responsibility of the corresponding author to obtain written permission to reproduce any photographs or other copyright material.

REVIEW

All manuscripts are sent for blind peer-review to members of the editorial board and guest reviewers. The review process generally requires three months. The receipt of submitted manuscripts will be acknowledged by the editor, from whom a decision and reviewers' comments will be received when the peer-review has been completed. Papers submitted to the journal must not previously have been published, and must not be submitted for publication to any other journal while under consideration for *Queensland Review*.

STYLE AND REFERENCING

For details of the *Queensland Review* style, please see the style and referencing guide available at journals.cambridge.org/qre

1. Authors should follow Australian spelling and punctuation conventions throughout their articles (except in quotations from other sources, where the spelling convention of the original should be retained). Use the Oxford English Dictionary.
2. Use single inverted commas, except for quotations within quotations (which have double inverted commas). Punctuation should follow closing inverted commas except for grammatically complete sentences beginning with a capital.
3. Since *Queensland Review* is a multi-disciplinary journal, we accept referencing using either the short-title (endnote) system or the author-date (Harvard) system, depending on the disciplinary base on the author. Each individual paper must conform to one or other of these systems.
4. Use endnotes, not footnotes.
5. Include a bibliography only if the author-date (Harvard) system of referencing is used.
6. Generally notes should be kept brief. Source references should be given with as little additional matter as possible.
7. Quotations should be kept to a minimum and lengthy quotations should be avoided. As a general rule, quotations of more than about 60 words should be set off from the main text (indented with extra space above and below). Those of fewer than 60 words should run on in the text inside inverted commas.
