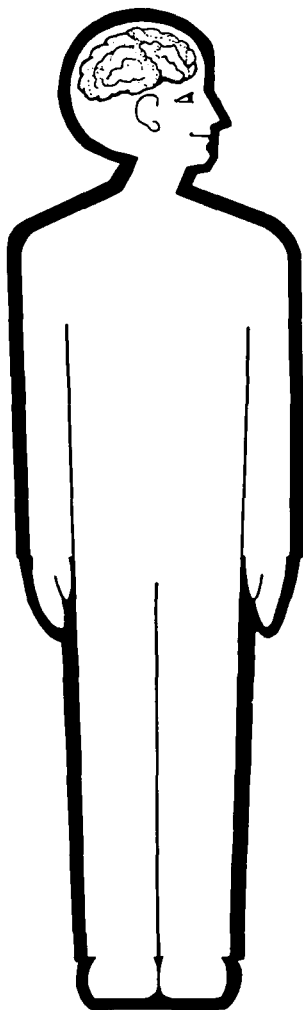

The frontiers of speech communication research have been pushed outward ever more rapidly in recent years. This book, which records and reviews the latest progress, is dedicated to Gunnar Fant, a pioneer in the field of speech communication research. His influence on the whole subject is most visible in his application of physics and engineering to human speech and behaviour, and his insistence on the central role of the acoustic signal. A variety of topics is covered in this book: the quantitative modelling of the human vocal tract and its acoustical properties; acoustic phonetic descriptions of various languages; the perception of speech and the development of objective measures of speech quality; applications of speech research; and the development of distinctive feature frameworks for linguistic theory. These original research reports, together with a number of review articles, provide a broad, up-to-date survey that makes the book a valuable reference work.

Around 1800 a few attempts were made at surveys of the world's languages on a global scale (ca. 1787 by Pallas, ca. 1805 by Panduro, ca. 1806 by Adelung), but since then no such project has successfully been undertaken. The aim of LDS (*Lingua Descriptive Studies*) is to provide such a survey. This will take the form of clearly organized descriptions. Each volume will describe the syntax, morphology and phonology of one language. Thus, an encyclopedic series will develop, which will provide linguists, whatever their theoretical background, with a comparative basis for the study of universals of language and typology. All descriptions will be organized along the same lines, in order to facilitate comparisons between the languages. The intention is to present, every year, languages from different major language groups, so that these will all be equally represented.
