continued to enjoy subsequently as a member of the senior XV of the Clontarf Rugby Club.

After 'house jobs' in Dublin and in hospitals in England and Wales, he began his psychiatric career as an assistant medical officer at Carlow District Mental Hospital, Eire, where he was greatly influenced by the then superintendent, Dr Green, whose progressive methods of psychiatric treatment were well known.

In 1962 Glass was appointed to a World Health Organization Fellowship and

travelled in Finland, Holland and Switzerland, and was able to incorporate the best of their psychiatry in his subsequent treatment of patients.

He was appointed medical superintendent at St Davet's Hospital in 1948 and continued his distinguished career there until he retired in 1972. In 1935 he gained the DPM (Royal College of Physicians and Surgeons of Ireland), and in 1971 he was elected to the Foundation Fellowship of the Royal College of Psychiatrists.

He was predeceased by his wife, the former Murielle Slocock, and is survived

by their son, Tim, his wife and their three children.

### Self-help CD-ROM to tackle anxiety or depression

Following successful field testing, the Mental Health Foundation has launched a new self-help CD-ROM for anyone experiencing mild to moderate anxiety and/or depression. The CD-ROM, *Restoring the Balance*, is specifically designed to provide users with information and strategies for managing anxiety or depression. Although primarily designed for use in primary care settings, such as general practitioner surgeries where a practitioner is available to provide post-session support, this new program

can also be used on its own by mental health service users. Its straightforward graphics make it particularly suitable for people who have little or no previous experience of using computers, and the CD-ROM comes complete with worksheets.

*Restoring the Balance* has been successfully field tested in a primary care setting with patients experiencing anxiety and depression. In comparison with a control group, use of the program by patients was found to have a positive impact on calmness and mood, measured on the Hospital Anxiety and Depression scale.
