This is an entirely new book with an original approach to the subject. It concentrates particularly on those aspects of the law of damages which have been inadequately covered elsewhere. Two of these particularly receive detailed study; full consideration is given to the fundamental rules of the law of damages, and there is an original and comprehensive discussion on the means of assessing damages.

In considering fundamental rules the author has not only studied English decisions but has looked for general principles in the case-law of the British Commonwealth.

The assessment of damages does not as yet permit the application of definite scientific rules. Professor Street has, however, taken a step towards remedying this in his attempt to discover how far actuarial techniques can be employed to measure damage in personal injury claims. His conclusions, which are set out in full in this book, will be of the greatest assistance to anyone concerned with claims for damages.
