By looking at these women through their works, Lewalski documents the flourishing of a sense of feminine identity and expression in spite of—or perhaps because of—the constraints of the time. 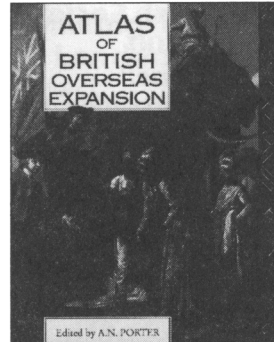

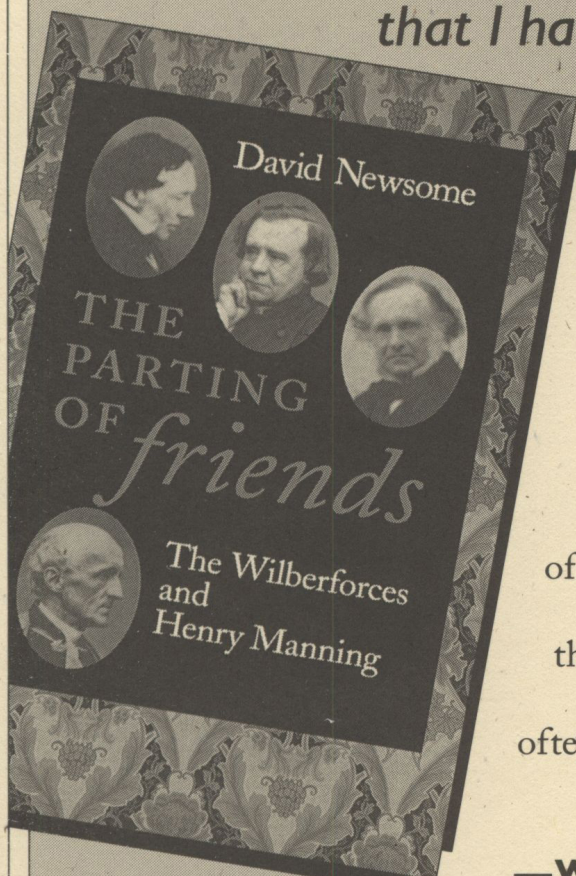

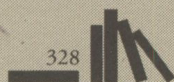
