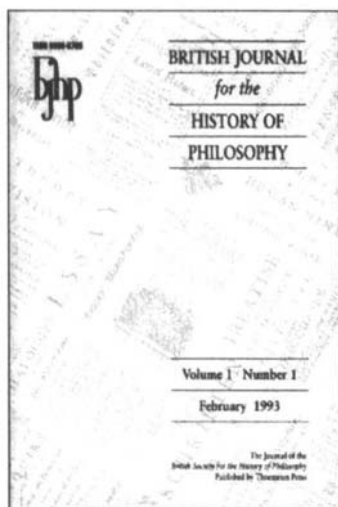

The first issue of the *British Journal for the History of Philosophy* was published in February 1993 and has filled a long-standing gap in the range of British Philosophy journals. Appearing twice a year, it includes articles and reviews on the history of philosophy and related intellectual history from the ancient world through to the early decades of the twentieth century, with particular emphasis on the period from the Renaissance to the 1940s. The journal's primary objective is to foster understanding of the history of philosophy through a deeper appreciation of the argument of past philosophers by a study of their texts, and through a proper awareness of the context – intellectual, political, and social – in which the text was created. Although full attention is given to the recognized classics of philosophy, due consideration is also given to the less major figures and to issues in disciplines other than philosophy as currently conceived – theology, the natural sciences, and the social sciences for instance – in so far as they throw light on the history of philosophy.

The *British Journal for the History of Philosophy* is the official journal of the *British Society for the History of Philosophy*. The editor is Dr. G.A.J. Rogers (University of Keele).
