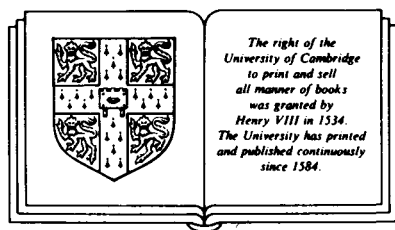

The Blue-Eyed Enemy

Japan against the West in Java and Luzon, 1942–1945

Theodore Friend

The Blue-Eyed Enemy is a comprehensive account of the interwoven histories of the three major archipelago-nations of the West Pacific during the years of the Second World War. Theodore Friend examines Japanese colonialism in Indonesia and the Philippines as an example of recurring patterns of domination and repression in that region. He depicts Japanese rule in Greater East Asia as expressive of the folly of the general who exhorted his troops "to annihilate the blue-eyed enemy and their black slaves." At the same time he clearly shows where the return of Western power aimed at new links between conqueror and conquered, or lords and bondsmen.

The Punjab under Imperialism, 1885–1940

Imran Ali

This comprehensive survey of British rule in the Punjab demonstrates that colonial policy making led to many of the socio-economic and political problems currently plaguing Pakistan and Indian Punjab. The Punjab—an area now divided between Pakistan and India—experienced significant economic growth under British rule from the second half of the nineteenth century. This expansion transformed the previously barren area into one of the most important regions of commercial agriculture in South Asia. Nevertheless, Imran Ali argues that colonial strategy distorted the development of what came to be called the "bread basket" of the Indian subcontinent.

Cochabamba, 1550–1900

Brooke Larson

Cochabamba is the principal agricultural region of Bolivia, with a peasantry that has been especially active in small-scale commercial agriculture and marketing. Focusing on this region, Brooke Larson supplies the first long-term historical view of rural society in colonial and nineteenth-century Bolivia.

Combining economic history and ethnohistory, the author shows how the contradictions of class and colonialism gave rise to new social forces from below that both accommodated and challenged the evolving structures of domination.
