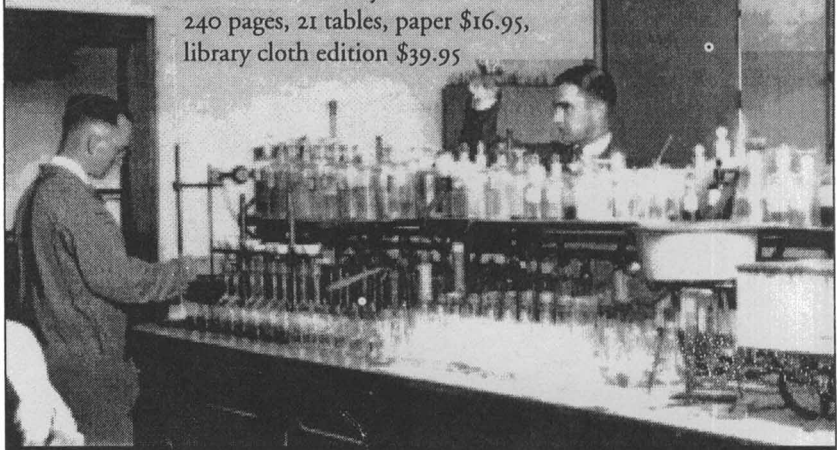

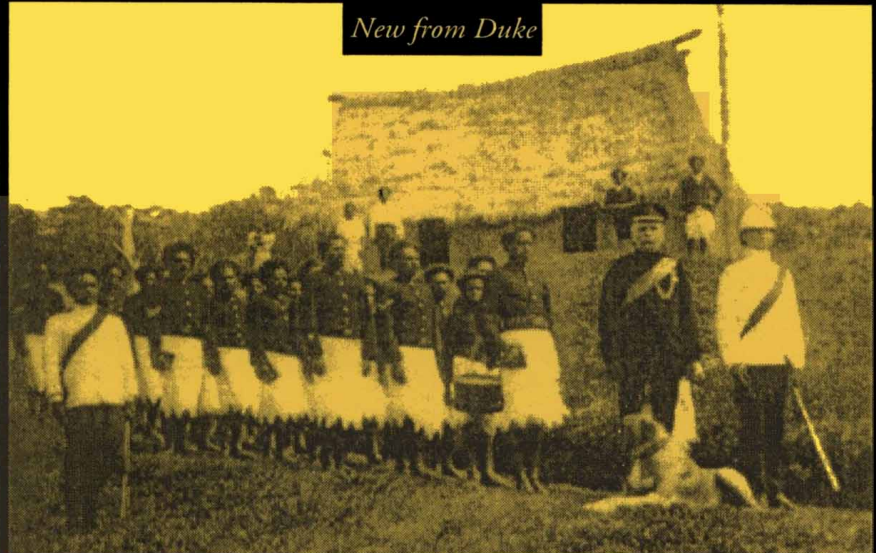

Ritual Politics and the Colonial Imagination in Fiji
Martha Kaplan

Engaging Fijian oral history and texts as well as colonial records, Kaplan resituates Tuka—a group of Fijians mobilized under the oracle priest Navosavakadua—in the flow of indigenous Fijian history-making and rereads the archives for an ethnography of British colonizing power.
