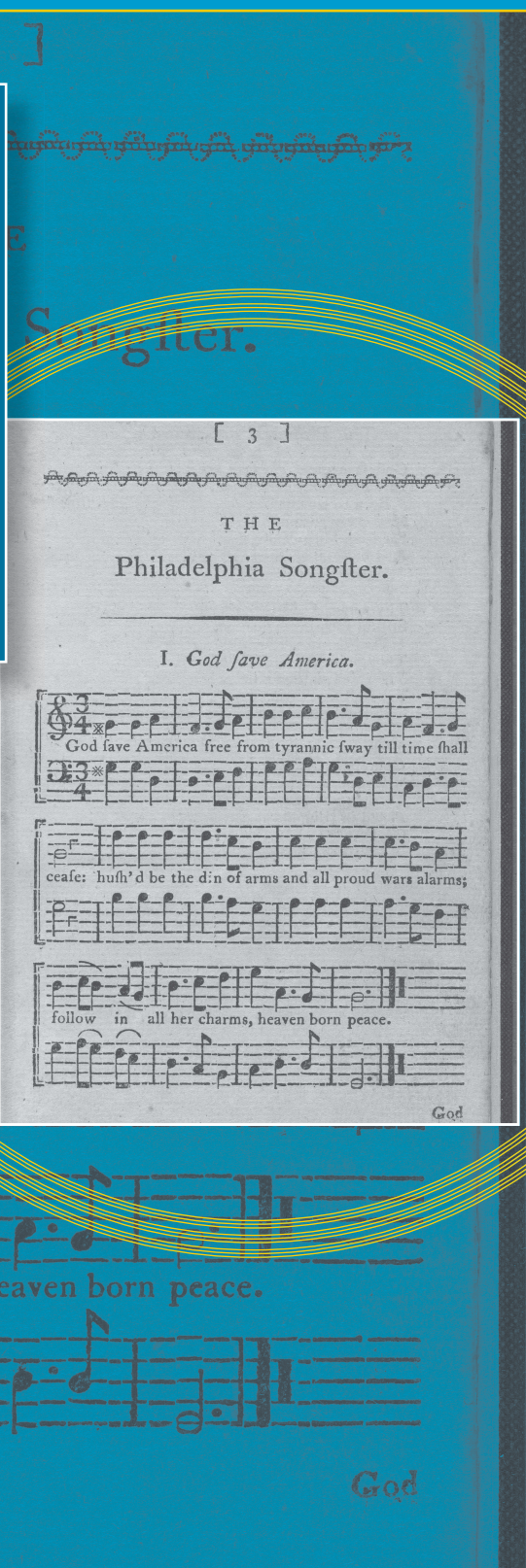

## Contributors

**Alexandra Apolloni** holds a Ph.D. in musicology from UCLA and is program coordinator at the UCLA Center for the Study of Women. In 2012, she received an Alvin H. Johnson AMS-50 Fellowship from the American Musicological Society. Her work has appeared in numerous publications, including the *Journal of Popular Music Studies*, *The Avid Listener*, *The Toast*, and *Hippo Reads*. She is currently completing a monograph about vocal performances of race and gender by young women singers in 1960s British popular music.

**Christina Baade** is an associate professor and university scholar in the department of communication studies and multimedia at McMaster University. Her publications include her award-winning book, *Victory Through Harmony: The BBC and Popular Music in World War II*, and a collection, co-edited with James Deaville, *Music and the Broadcast Experience: Performance, Production, and Audiences*. Current projects include the SSHRC-funded *Bigger than the Beatles? Vera Lynn's Postwar Career and the Problems of Popular Music History*.

An independent scholar, **Edward A. Berlin** has written extensively and lectured widely on the subject of ragtime. His books *Ragtime: A Musical and Cultural History* (1980), *Reflections and Research on Ragtime* (1987), and *King of Ragtime: Scott Joplin and His Era* (1994; 2nd ed. 2016) suggest new standards for researching American vernacular music of the period.

**Glenda Goodman** is an assistant professor of music at the University of Pennsylvania. She is currently writing a book about the material and social history of amateur music making, focusing on a group of men and women who grew up following the American Revolution. Her previous work on transatlantic music, sacred music, and colonial encounter has appeared in the *Journal of the American Musicological Society*, *William and Mary Quarterly*, *Common-Place*, and *Oxford Music Online*.

**Naomi Graber** is an assistant professor at the University of Georgia. Her research concerns Kurt Weill's work in the United States with a focus on issues of immigration and acculturation, and more broadly, film and theater of the 1930s. She is also interested in contemporary Broadway and Hollywood practices. Her work has appeared in *Studies in Musical Theatre*, and she is a frequent contributor to blogs such as *Musicology Now* and *Trax on the Trail*.

**Stephanie Jensen-Moulton** is an associate professor of musicology at Brooklyn College, City University of New York, whose publications include work on women in hip hop, "Blind Tom" Wiggins, and Pauline Oliveros. She received CUNY's

Carolyn Heilbrun Prize for her study of Miriam Gideon's 1958 opera, *Fortunato*, and a Whiting Fellowship for teaching excellence. She is co-editor of the *Oxford Handbook of Music and Disability Studies*, and her current project explores intersections between disability and American opera.

**Renee Lapp Norris** is a professor of music and chair of the department of music at Lebanon Valley College in central Pennsylvania. She teaches courses in European, North American, and non-Western music. Her Ph.D. in musicology was awarded by the University of Maryland in 2001. Norris's work on minstrelsy appears in *JSAM*, the *Grove Dictionary of American Music*, 2nd edition, and elsewhere. Her current project is a MUSA edition, *Opera Parody Songs of Blackface Minstrels, 1844–1860*.

An associate professor of musicology at Arizona State University's School of Music, **Kay Norton** writes about American sacred music, music of the American South, and music's association with wellness. She has been published in *American Music*, *The Hymn*, and *Journal of Medical Humanities*. Her recent monograph, *Singing and Wellbeing: Ancient Wisdom, Modern Proof* (Routledge, 2016), centralizes the melodious voice in human existence by drawing on research from several disciplines, including anthropology, evolution, medical history, and neuroscience.

**Graham Raulerson** is an assistant professor of music at East Los Angeles College. His research focuses on political dimensions of American music, particularly the musical practices of the hobo subculture and the music and writings of Harry Patch. He is currently working on a book, tentatively titled "Westbound: Hobo Music and Cultural Survival in Dangerous Times," which examines hoboes' use of song as a means of overcoming existential threats in the twentieth and twenty-first centuries.

**Kim Simpson** is the author of *Early 70s Radio: The American Format Revolution* (2011). He is a writer and musician who lives in Austin, Texas. His website is [www.kimsimpson.us](http://www.kimsimpson.us).

**Michael Sy Uy** holds degrees from the Universities of California Berkeley and Oxford and is a doctoral candidate at Harvard University. His research focuses on the music and performing arts programs of the Rockefeller Foundation, the Ford Foundation, and the National Endowment for the Arts. He is a founding member of the Hearing Landscape Critically network. The oral version of his article won the Society for American Music's Mark Tucker Award for Outstanding Student Paper at the 2015 conference.

**Marian Wilson Kimber** is an associate professor of musicology at the University of Iowa. She is the author of articles on the biographies and reception of Felix Mendelssohn and Fanny Mendelssohn Hensel. Her recent book, *The Elocutionists: Women, Music, and the Spoken Word*, explores the intersection of poetic recitation and music by women in American cultural life. Wilson Kimber's current research examines women composers' concerts in the 1930s.
