The British Journal of Nutrition is published by the Cambridge University Press for The Nutrition Society, which owns it and controls its publication. It is devoted to reports of original work in all branches of nutrition. A volume will consist of four parts appearing at quarterly intervals.

The Proceedings of The Nutrition Society, which are at present published separately, will, after the completion of Volume 5, be merged in the *British Journal of Nutrition*. These *Proceedings* in part record meetings of the type held by the Society during the war, at which experts in a particular field are invited by Council to make contributions on specific parts thereof, and at which general discussion follows these invited contributions. It is proposed at present to publish these but not summaries of the discussions. The Society also holds scientific meetings at which papers are communicated by members and others on original work carried out by them. It is proposed at present to publish summaries of these papers, of which about ten may be read at each meeting, each communication being recorded, at the author's option, in the Society's *Proceedings* by means of an abstract not exceeding 200 words in length.

It is intended that both kinds of meeting shall be held in England and Scotland, as has hitherto been the practice with the first kind.

The Nutrition Society has as its object the advancement of the scientific study of nutrition and its application to the maintenance of human and animal health.

Membership is open to any whose work has contributed to the scientific knowledge of nutrition, whether such work has been in the laboratory, the field or the clinic, and whether experimental, clinical, agricultural or statistical in nature.
