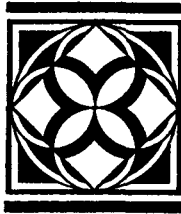

THE DESTINY OF THE WARRIOR

Dumézil's comparative studies have shown that the common ideology retained by the Indo-European peoples from their former unity is expressed in three levels or functions—sovereignty, force, and fecundity. *The Destiny of the Warrior* is a comparative exploration of the many aspects of the second function. The study shows that the myths of the Indian warrior god Indra are similar in intention and outline to the legends of the reign of the Roman warrior King Tullus Hostilius. By comparing Indian, Scandanavian, and Greek tradition Dumézil takes up the epic theme of three sins committed successively by the warrior. Part three, of this study, illuminates through Armenian, Scandanavian, Irish, and Gallic parallels, a number of characteristics of the Indra myths.

For the past thirty years Georges Dumézil has been well known to religious historians as the champion of a new, structural interpretation of Indo-European religious institutions and mythologies. Dumézil contends that the Indo-European heritage of Roman religion provides fixed points from which it is possible to understand the evolutions toward the form of Roman religion which we recognize today. He deals specifically with the pre-Capitoline triad and with the historical appearance and probable meaning of the Capitoline triad. The author goes on to observe the ways by which the primitive pantheon developed and to sketch the history of the religion up to the end of the Republic. Finally, Dumézil considers the organization of the cult, priesthoods, and divine signs.

THE CHURCH UNDER THE LAW

RONALD A. MARCHANT

This is the first systematic account of church courts as they were re-molded to serve the Protestant church in England after the Elizabethan Settlement, and at a time when they were still one of the principal responsibilities of bishops and archdeacons.

Based on detailed accounts of the courts in the diocese of York (1560-1640), Dr Marchant discusses the lawyers and the ecclesiastical 'civil service', the amount and nature of the business transacted by the courts, and the sources of administrative law. He also examines the church's attempts to dictate the morals of the population and analyzes its effectiveness and results.

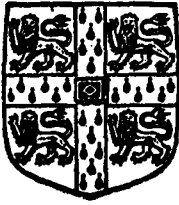
